

TRIBAL RESOLUTIONS PURSUANT TO THE ADAM WALSH CHILD PROTECTION AND SAFETY ACT OF 2006

The Adam Walsh Child Protection and Safety Act of 2006 (Walsh Act) provides that each federally-recognized tribe may elect to retain the authority over sex offender registry functions within the tribal territory, unless the tribe is subject to the criminal jurisdiction of a State under 18 U.S.C. § 1162. The attached document lists all 562 federally-recognized tribes, indicates their eligibility to elect to fulfill sex offender registry functions under the Walsh Act, and indicates which tribes have made such an election.

The list of federally-recognized tribes was compiled from documentation from the Bureau of Indian Affairs (BIA), U.S. Department of the Interior, the entity responsible for federal recognition. The primary source document was the most recently published listing in the Federal Register, *Indian Entities Recognized and Eligible to Receive Services from the United States Bureau of Indian Affairs*, 72 Fed. Reg. 1,648 (Mar. 22, 2007). Due to a few instances of ambiguity in the Federal Register list¹, however, other BIA sources, such as a numbered list from the office within the BIA responsible for federal recognition, were also consulted.

As stated above, tribes subject to the criminal jurisdiction of a State under 18 U.S.C. § 1162 are ineligible to elect to serve as registry jurisdictions, 42 U.S.C. § 16927(a)(2)(A); therefore, determining criminal jurisdiction was critical to creating this list. Using this standard, only 212 tribes are eligible to make the Walsh Act election. This includes 204 tribes whose lands are entirely within States that do not exercise jurisdiction under 18 U.S.C. § 1162. In addition, there are seven tribes that are partially subject to the law enforcement jurisdiction of a State; that is, the tribal territory exists in more than one State, and at least one of those States exercises jurisdiction over the tribe under 18 U.S.C. § 1162. In this situation, the tribe is eligible to elect to retain authority over its sex offender registry functions only for the territory in the State not subject to 18 U.S.C. § 1162. *Proposed National Guidelines for Sex Offender Registration and Notification*, 72 Fed. Reg. 30,215 (May 30, 2007) Finally, the list includes one tribal component that is not subject to the criminal jurisdiction of a State by reason of a retrocession of jurisdiction for that component only.

Finally, the list indicates that the SMART Office has received a total of 278 tribal resolutions (or similar enactments), each purporting to indicate whether the tribe or other entity elected to retain authority over its sex offender registry functions. Of this total number, 75 were received from tribes or other entities ineligible to make the election. Of the 212 tribal entities eligible to make the election, 198 chose to retain sex offender registry functions and 5 submitted resolutions affirmatively delegating the registry function to the State. Nine eligible entities did not file a resolution or other similar enactment. The SMART Office contacted (by telephone, email and registered letter) each eligible tribe that did not make any election to ensure the accuracy of our records. Per the

¹ For example, the list includes the names of six component bands that collectively make up the Minnesota Chippewa Tribe, but left unclear whether each component band was a "federally-recognized tribe." Reference to unofficial BIA documents clarified that only the large tribe qualifies for that moniker.

Walsh Act, for these nine tribes the registry function is automatically delegated to the State.
