SUBJ: VILLAINY BY NIGHT

- 1. UNASYG AND I ARE CONVINCED ON THE BASIS OF EVIDENCE WE BOTH REGARD AS CONCLUSIVE THAT BOMBING OF NON-MILITARY AREAS IN DACCA LAST NIGHT (AND INFERENTIALLY BOMBING OF ORPHANAGE ON NIGHT OF DEC 8-9) WERE CARRIED OUT BY A PAK GOVT PLANE BASED AT DAGGA AIRPORT AND THAT THE PURPOSE OF ATTACKS WAS TO DISCREDIT THE INDIAN AIR FORCE.
- 2. EVIDENCE WHICH HAS BROUGHT US TO THIS CONCLUSION CONSISTS GENERALLY OF FOLLOWING:

A. SOUND OF ENGINES OF PLANE CARRYING OUT
BOMBING WAS MARKEDLY DIFFERENT FROM THAT OF JETS OF
IAF WHICH HAVE BEEN OBSERVED IN PREVIOUS ATTACKS; UN
AIRCRAFT EXPERT HAS GIVEN HIS OPINION THAT THE SOUND WAS
COMPATIBLE WITH THAT OF SMALL TWIN ENGINE PROP AFFICRAFT,
ALMOST CERTAINLY THE PLAGGIO P-136-L, AT LEAST ONE OF
WHICH WAS SEEN BY ARMA AS RECENTLY AS A WEEK AGO AT
DACCA AIRPORT. CONGEN EMPLOYEE OF 10TH FLOOR OF
INTERCONTINENTAL HOTEL FACING AIRPORT SAW PLANE TAKE
OFF FROM AIRPORT AND HEARD IT GIRCLE
IMMEDIATELY PRIOR TO BOMB EXPLOSIONS. ANOTHER CONSULAR
EMPLOYEE ALSO HEARD AIRCRAFT AND BELIEVES HE SAW BOMB
DROPPED, AFTER WHICH PLANE CUT ITS ENGINES AND PRESCUMABLY LANDED AT NEARBY DACCA AIRPORT. SENIOR LOCAL
EMPLOYEE ALSO SAW PLANE, RECONSIZED IT AS TWIN-

ENGINE CRAFT KEPT AT AIRPORT FOR VIP USE, AND OBSERVED THAT CABIN LIGHTS WERE ON DURING FLIGHT.

B. IN CONTRAST TO PREVIOUS NIGHT BOMBINGS WHEN INDIAN AIRCRAFT WERE INVOLVED, THERE WAS VIRTUALLY NO ANTI-AIRCRAFT FIRE, NOT AT ALL EXCEPT FOR TWO SMALL TRACER ROUNDS FIRED AT AN ANGLE AWAY FROM SITE OF BOMBING.

C. RECOVERED NEAR SCENE OF ONE OF BOMBS AND CURRENTLY
IN POSSESSION UNEPRO IS OBJECT WHICH CANNOT HAVE ANY
OTHER PURPOSE THAN THAT OF MAKESHIFT BOMB RACK; THIS
OBJECT CONSISTS OF BOARDS NATLED TOGETHER TO
FORM RECTANGULAR BASE APPROXIMATELY SIZE OF SPACE BETWEEN
CABIN AND FLOAT SUPPORT OF PIAGGIO AIRCRAFT.
FIXED TO THIS BAORD ARE TWO SEMI-CIRCULAR METAL
BRACKETS FACING DOWNWARD; DANGLING FROM THE METAL BRACKETS
IS A WEB OF WHITE HARNESS BELTING AND VARIOUS
PIECES STRONG TWINE; OBVIOUS INFERENCE IS THAT THIS MAKESHIFT
BOMB RACK WAS FABRICATED FOR USE WITH PIAGGIO AIRCRAFT
IN ACCOMPLISHING LAST NIGHT'S MISSIONS; FACT THAT IT FELL
OFF AND COULD BE RECOVERED IS PROBABLY ACCIDENT.

D. BASIS FOR INFERENCE THAT BOMBING OF ORPHANAGE ON NIGHT 8-9 DEC WAS OF SAME PATTERN IS FOUNDED ON SIMILARITY OF AIRCRAFT SOUNDS, ABSENCE OF ANY ANTI AIRCRAFT FIRING.

3. HENRY IS INFORMING SYG URGENTLY OF HIS CONCLUSIONS IN THIS AFFAIR AND IS CONSIDERING WHAT OTHER STEPS HE CAN TAKE. HE IS AFRAID THAT UNEPRO POSSESSION OF INCRIMINATING BOMB RACK DEVICE MIGHT LEAD TO SUBSEQUENT ATTACK BY PAF TO DESTROY EVIDENCE BY BOMBING UN COMPOUND. HE IS ALSO CONCERNED FOR SAFETY OF RED CROSS NEUTRALIZED ZONES (INTERCONTINENTAL HOTEL WHERE SOME 500 FOREIGN NATIONALS AWAITING EVACUATION AND HOLY FAMILY HOSPITAL) SINCE HE CONCEIVES THAT PAF MAY ENGAGE IN FURTHER STUNTS THISNATURE IN ATTEMPT SOLIDIFY CASE AGAINST INDIAN AIR FORCE. MEMBERS OF UN STAFF HAVE ADVISED PAUL MARC HENTY AGAINST ATTEMPT CONFRONG ANY DACCA OFFICIALS WITH EVIDENCE FOR FEAR THAT WHOEVER DOES THIS MIGHT IMMEDIATELY BE IMPRISONED OR DISAPPEAR. UN HAS PHOTGRAPHED BOMB RACK AND IS CON-

SIDERING DISPOSING OF IT IN OBVIOUS AND DISINGENUOUS FASHING BY SIMPLY PLACING IN IN THE STREET.

- A. I STRONGLY URGE THAT AMBASADOR FARLAND AND AMBASSADOR BUSH (POSSIELY IN CONSULTATION WITH SYG) MAKE IMMEDIATE DEMARCHE TO PRESIDENT YAHYA AND PAK UN REP SHAHI TO CONFRONT THEM WITH EVIDENCE AND WARN THEM THAT ANY FUTURE ATTEMPT OF THIS KIND WILL BRING ABOUT FULL PUBLICITY. ALREADY RUMOR CIRCULATING WIDELY AMONG BENGALIS AND FOREIGNERS IN INTERCONTINENTAL HOTEL THAT BOMBINGS WERE WORK OF PAKISTANIS. HOWEVER, THERE IS AGREEMENT BETWEEN HENRY AND ME THAT NEITHER ONE OF WILL MAKE ANY COMMENT OF ANY KIND ON THESE RUMORS.
- 5. I AM FULLY CONCIOUS, AS IS PAUL MARK HENRY, OF GRAVITY OF CHARGES WE ARE MAKING. HOWEVER, I BELIEVE THAT DEMARCHE I HAVE OUTLINED IS ONLY TO PUT AN END TO THIS KIND OF UNSCRUPULOUS BARBARITY WHICH HAS ALREADY COST THE LIVES OF SEVERAL HUNDRED ORPHANS IN DACCA.
