REVOLUTIONARY GROUPS TODAY DETAINED MR. BRUKE ELBRICK, U.S. AMBASSADOR, TAKING HIM TO ANOTHER PART OF THE COUNTRY WHERE THEY WILL HOLD HIM PRISONER.

THIS ACT IS NOT AN ISOLATED EPISODE. IT IS ONE OF NUMEROUS REVOLUTIONARY ACTIONS ALREADY IN PROGRESS: BANK ROBBERIES, WHERE WE GET MONEY FOR THE REVOLUTION, TAKING IN RETURN WHAT THE BANKERS TAKE FROM THE PEOPLE AND ITS EMPLOYEES; TAKING OVER ARMY QUARTELS AND POLICE STATIONS, WHERE ARMS AND AMMUNITION ARE ACQUIRED FOR THE STRUGGLE TO OVERTHROW THE DICTATORSHIP; LIBERATING REVOLUTIONARIES AND RETURNING THEM TO THE STRUGGLE OF THE PEOPLE; BOMBING OF BUILDINGS SYMBOLIZING OPPRESSION; AND SENTENCING EXECUTIONERS AND TORTURERS.

TRULY THE CAPTURE OF THE AMBASSADOR IS JUST ONE MORE ACT IN THE REVOLUTIONARY WAR THAT MOVES FORWARD EACH DAY AND WHICH THIS YEAR IS GOING TO BEGIN THE RURAL GUERRILLA STAGE. WITH THE CAPTURE OF THE AMBASSADOR AND TO SHOW THAT IT IS POSSIBLE TO OVERCOME THE DICTATORSHIP AND EXPLOITATION, WE ARE ARMED AND WELL ORGANIZED. WE WILL APPEAR WHERE THE ENEMY LEAST EXPECTS US AND IMMEDIATELY DISAPPEAR, WEAKENING THE DICTATORSHIP, BRINGING TERROR AND FEAR TO THE EXPLOITERS. AND BRINGING HOPE OF CERTAIN VICTORY TO THE EXPLOITED.

MR. ELBRICK REPRESENTS IN OUR COUNTRY THE INTEREST OF IMPERIALISM WHICH IS ALLIED WITH THE BIG BOSSES, THE BIG LANDOWNERS, AND THE BIG NATIONAL BANKS TO MAINTAIN THE REGIME OF OPPRESSION AND EXPLOITATION.

THE INTERESTS OF THESE PARTNERS LAY IN MAKING THEMSELVES EVER

MORE RICH AND IN CREATING AND MAINTAINING WAGE FREEZES, THE UNJUST

AGRARIAN STRUCTURES AND INSTITUTIONALIZED REPRESSION: HOWEVER,

THE KIDNAPPING OF THE AMBASSADOR IS A CLEAR WARNING THAT THE BRAZILIAN

PEOPLE WILL NOT GIVE THEM (BIG BOSSES, ETC.) REST AND AT ANY
TIME WILL MAKE THEM FEEL OUR WEIGHT IN THIS STRUGGLE. THEY
ALL KNOW THAT THIS IS A STRUGGLE, THEY ALL KNOW THAT THIS
IS A STRUGGLE WITHOUT TRUCE, A LONG AND DIFFICULT STRUGGLE
WHICH WILL NOT END WITH THE EXCHANGE OF ONE GENERAL FOR
ANOTHER BUT WILL ONLY END WITH THE TERMINATION OF THE REGIME
OF THE BIG EXPLOITERS AND WITH THE CONSTRUCTION OF A GOVERNMENT
WHICH LIBERATES THE WORKERS OF THE COUNTRY FROM THE SITUATION
IN WHICH THEY FIND THEMSELVES.

THIS IS INDEPENDENCE WEEK, THE PEOPLE AND THE DICTATORSHIP OBSERVE THIS WEEK IN DIFFERENT MANNERS. THE DICTATORSHIP HAS PARTIES AND PARADES, SETS OFF FIREWORKS AND PUTS UP POSTERS. WITH THIS THE DICTATORSHIP REALLY DOES NOT WISH TO COMMEMORATE ANYTHING; WHAT IT WANTS TO DO IS THROW SAND IN THE EYES OF THE EXPLOITED, GIVING THEM A FALSE JOY WITH THE OBJECT OF HIDING THEIR LIFE OF MISERY. EXPLOITATION AND REPRESSION. BUT CAN YOU BLOT OUT THE SUN WITH A DOT? CAN YOU HIDE FROM THE PEOPLE THEIR MISERY WHEN THEY FEEL IT INSIDE THEM?

IN THE WEEK OF INDEPENDENCE THERE ARE TWO CELEBRATIONS:
THAT OF THE DICTATORSHIP,
THAT OF THE PEOPLE.

THAT OF THOSE WHO ORGANIZE PARADES AND THAT OF THOSE WHO KIDNAPPED THE AMBASSADOR, SYMBOL OF EXPLOITATION. THE LIFE AND DEATH OF THE AMBASSADOR ARE IN THE HANDS OF THE DICTATORSHIP.

IF THEY WILL RESPOND TO TWO DEMANDS, MR. ELBRICK WILL BE LIBERATED. IF NOT, WE WILL BE OBLIGED TO CARRY OUT REVOLUTIONARY JUSTICE. OUR TWO DEMANDS ARE:

A. THE LIBERATION OF 15 POLITICAL PRISONERS. THEY
ARE 15 REVOLUTIONARIES IN THE THOUSANDS WHO SUFFER
TORTURE IN THE PRISONS AND MILITARY HEADQUARTERS
OF THE COUNTRY, WHO ARE BEATEN, ABUSED AND SUFFER
THE HUMILIATIONS IMPOSED BY THE MILITARY. WE ARE
NOT DEMANDING THE IMPOSSIBLE, WE ARE NOT DEMANDING
THAT LIFE BE RESTORED TO THE INNUMERABLE FIGHTERS
KILLED IN THE PRISONS. THEY WILL NOT BE LIBERATED OF
COURSE; THEY WILL BE CATTLE ONE DAY. WE DEMAND
ONLY THE LIBERATION OF THESE IS MEN, LEADERS IN
THE STRUGGLE AGAINST THE DICTATORSHIP. EACH ONE
OF THESE ARE WORTH A 100 AMBASSADORS FROM THE PEOPLES
POINT OF VIEW. BUT AN AMBASSADOR OF THE US IS ALSO

IN THE MAJOR NEWSPAPER AND RADIO STATIONS THROUGHOUT

THE COUNTRY. THE 15 POLITICAL PRISONERS MUST BE FLOWN IN A SPECIAL PLANE TO A PARTICULAR COUNTRY - ALGERIA, CHILE AND MEXICO - WHERE THEY WILL BE GIVEN ASYLUM. NO REPRISALS MUST BE ATTEMPTED AGAINST THEM UNDER PAIN OF RETALIATION.

THE DICTATORSHIP HAS 48 HOURS TO REPLY PUBLICLY IF IT
ACCEPTS OR REJECTS OUR PROPOSAL. IF THE RESPONSE IS POSITIVE
WE WILL PUBLISH A LIST OF THE 15 REVOLUTIONARY LEADERS AND WE
WILL WAIT 24 HOURS FOR THEM TO BE TAKEN TO A SAFE COUNTRY.

IF THE REPLY IS NEGATIVE OR IF THERE IS NO REPLY BY THIS TIME
MR. ELBRICK WILL BE EXECUTED. THE 15 COLLEAGUES MUST BE
LIBERATED WHETHER OR NOT THEY HAVE BEEN SENTENCED; THIS IS AN
"EXCEPTIONAL SITUATION", AND IN "EXCEPTIONAL SITUATIONS", THE
JURISTS OF THE DICTATORSHIP ALWAYS WORK OUT A WAY TO SETTLE
THINGS AS WE CAN SEE NOW IN THE RISE OF THE MILITARY JUNTA.

THE CONVERSATIONS WILL ONLY BE BEGUN AFTER THE PUBLIC AND OFFICIAL DECLARATION OF THE DICTATORSHIP THAT IT WILL RESPOND TO OUR DEMANDS. THE METHOD WILL ALWAYS BE PUBLIC ON THE PART OF THE AUTHORITIES AND ALWAYS UNPREDICTABLE ON OUR PART.

WE WISH TO REMIND THAT THE DEADLINES CANNOT BE EXTENDED AND THAT WE WILL NOT HESITATE TO FULFILL OUR PROMISES.

FINALLY, WE WANT TO WARN ALL THOSE WHO TORTUE, BEAT UP AND KILL OUR COLLEAGUES THAT WE ARE NOT GOING TO TOLERATE THE CONTINUATION OF THIS HATED PRACTISE. WE ARE GIVING YOU THE LAST WARNING. WHO CONTINUES TORTURING, BEATING UP AND KILLING - BE ON YOUR GUARD.

BACKGROUND ON THE MOVIMENTO REVOLUCIONARIO-8

THE FOLLOWING IS BACKGROUND INFORMATION ON THE MOVIMENTO REVOLUCIONARIO-8 (THE 8 REFERS TO THE DATE OF "CHE" GUEVARA'S DEATH IN OCTOBER), ONE OF THE NUMEROUS TERRORIST ORGANIZATIONS IN BRAZIL WHICH, ALTHOUGH INDEPENDENT, HAVE INFORMAL LINKS.

IN LATE JULY AND EARLY AUGUST BRAZILIAN POLICE BROKE UP A RIO DE JANEIRO BASED SUBVERSIVE GROUP, KNOWN AS THE MR-8, WHICH HAD STAGED NUMEROUS BANK ROBBERIES AND CAR THEFTS IN RIO DE JANEIRO TO FINANCE A RURAL GUERRILLA WARFARE OPERATION IT PLANNED TO BEGIN IN THE STATE OF PARANA. THE GROUP REPORTEDLY HAD CONNECTIONS WITH SIMILAR GROUPS IN PARAGUAY AND ARGENTINA. ALTHOUGH ONE OF ITS MEMBERS HAD GIVEN MONEY TO THE REVOLUTIONARY BRAZILIAN COMMUNIST PARTY (A DISSIDENT COMMUNIST GROUP DEDICATED TO REVOLUTION) THE GROUP APPEARED TO BE INDEPENDENT.

FOUNDED IN NITEROI, CAPITAL OF RIO DE JANEIRO STATE (ACROSS THE BAY FROM RIO DE JANEIRO) IN MID-1968 BY NITEROI STUDENTS. THE GROUP EVENTUALLY WAS COMPOSED OF SOME 30 MEMBERS, AT LEAST 14 OF WHOM WERE STUDENTS.

THE GROUP HOPED TO ESTABLISH A SOCIALIST REGIME BY FORCE, BEGINNING WITH GUERRILLA WARFARE IN RURAL AREAS, SELECTING THE SOUTHWEST CORNER OF PARANA STATE NEAR THE PARAGUAYAN AND ARGENTINE BORDERS. TO GET FUNDS FOR GUERRILLA WARFARE

THE GROUP BEGAN A SERIES OF BANK ROBBERIES IN THE RIO DE JANEIRO AREA. THE BANK ROBBERIES WERE SUSPENDED AFTER THE GROUP RECRUITED JORGE MEDEIROS VALE, ASSISTANT MANAGER OF A BRANCH OF THE BANK OF BRAZIL WHO, ACCORDING TO HIS OWN ACCOUNT, SUCCEEDED IN EMBEZZLING THE EQUIVALENT OF MORE THAN TWO MILLION U.S. DOLLARS FROM THE BANK.

FUNDS RECEIVED FROM VALE AND FROM THE ROBBERIES WERE USED TO ESTABLISH A SYSTEM OF SAFE HOUSES FOR ITS MEMBERS IN SEVERAL STATES, 18 HOUSES OR APARTMENTS IN GUANABARA STATE ALONE.

POLICE STUMBLED ON THE GROUP AFTER POLICE FOUND ARMS
IN THE CAR OF AN MR-8 MEMBER INVOLVED IN A TRAFFIC ACCIDENT.

VALE, WHO ADMITTED DONATING \$100,000 TO THE MR-8 AND \$150,000 TO THE PCBR, SAID THAT HE HAD UNSUCCESSFULLY ATTEMPTED TO CONTACT REPRESENTATIVES OF THE ALGERIAN NATIONAL LIBERATION FRONT AND EXILED BRAZILIAN POLITICIANS IN PARIS. HE SAID THAT HE HAD INTENDED EVENTUALLY TO JOIN THE TERRORIST GROUP LED BY DISSIDENT COMMUNIST CARLOS MARIGHELLA.

DURING THE QUESTIONING OF ARRESTED MR-8 MEMBERS, ALLEGATIONS
WERE MADE THAT MEMBERS OF THE GROUP HAD CONTACTS WITH THE
FORMER SYRIAN AMBASSADOR TO BRAZIL, JAMIL CHAYA, FROM WHOM
THEY SAID THEY OBTAINED INFORMATION ON THE ACTIVITIES AND
METHODS OF THE AL FATAH, ARAB TERRORIST GROUP, AS WELL AS
