Multiple deployments, trauma (psychological, neurological, and physical), and reintegration challenges have far-reaching effects on the behavioral and social health of Service Members, Veterans, and their Families (SMVF). An effective response requires bridging cultures and systems to develop an integrated system with appropriate continuity of care measures provided. This response involves going beyond the longstanding systemic barriers of behavioral health systems to create a collaborative approach addressing the full impact of a decade of war on SMVF and our communities. 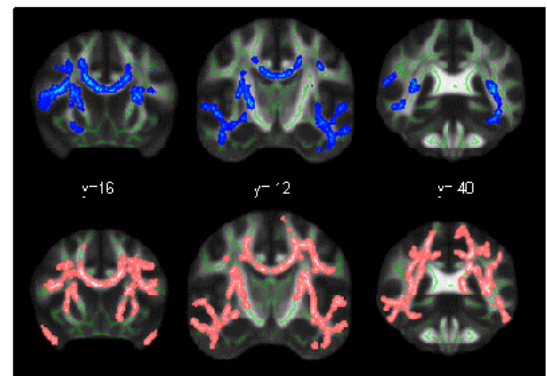
Effects of mild traumatic brain injury and posttraumatic stress disorder on white matter integrity in post-9/11 veterans.

Top Poster - Blue Ribbon Award:

Clinical predictors of white matter disruption in chronic mild traumatic brain injury among post-9/11 veterans

Background: Mild traumatic brain injury (TBI) is a signature injury of the wars in Iraq and Afghanistan. With no overt lesions on conventional MRI, diagnosis relies on accurate history and assessment of behavioral symptoms that frequently overlap with comorbid PTSD and depression. Our goal was to assess white matter in relation to clinical predictors of TBI and PTSD.

Figure: Our results with DTI whole brain crossing fiber analysis shows that duration of loss of consciousness (blue, upper panel) and feeling dazed and confused (pink, lower panel) predicts disruption of white matter in mild TBI.

Conclusions: Assessment of crossing fibers, coupled with methodological advances for robust whole brain analyses confirm the presence of a diffuse pattern of white matter disruption predicted by loss of consciousness and by feeling dazed and confused. These findings are consistent with a mechanism of diffuse injury that involves a cascade of inflammatory and neurochemical events.

Outreach to Providers

Group Supervision for Clinicians Listening to Trauma Histories

Therapists treating PTSD often find themselves in parallel turmoil, as they react to the patient's inner and outer worlds. Good clinical supervision is essential. In addition to receiving guidance and support from an experienced colleague, having the opportunity to share one's often turbulent emotions and learning how these can be used to better understand the case are also important.
