We are writing to invite you or your designee to testify before the Subcommittee on Contracting Oversight at a hearing entitled, "Improving Federal Contract Auditing." The hearing will be held on Tuesday, February 1, 2011 at 2:30 P.M. in Room SD-342 of the Dirksen Senate Office Building.

The purpose of the hearing is to examine how federal agencies use contract audits to detect and prevent waste, fraud, and abuse in government contracts. In particular, the hearing will review the findings of the Subcommittee's ongoing investigation of the type and number of contract audits at federal agencies. The hearing will also examine the role played by the Defense Contract Audit Agency (DCAA) in performing contract audits for agencies other than the Defense Department.

Your testimony should address the importance of contract auditing to the management and oversight of government contracts. You should also discuss the challenges departments and agencies face when conducting contract audits. In addition, you should be prepared to discuss the need for alternative approaches to strengthen contract auditing, including the potential advantages and disadvantages of creating a new Federal Contract Audit Agency.

We request that you summarize your testimony in 5 minutes, although a longer written statement may be submitted for the official record. This will allow adequate time for you to engage in questions and answers with members of the Subcommittee. **Subcommittee rules require that your testimony be submitted by no later than 2:30 P.M. on Friday, January 28, 2011.** Please send an electronic copy of your written statement and a brief one page biography to Subcommittee Clerk, Kelsey Stroud, at Kelsey.Stroud@hsgac.senate.gov.
