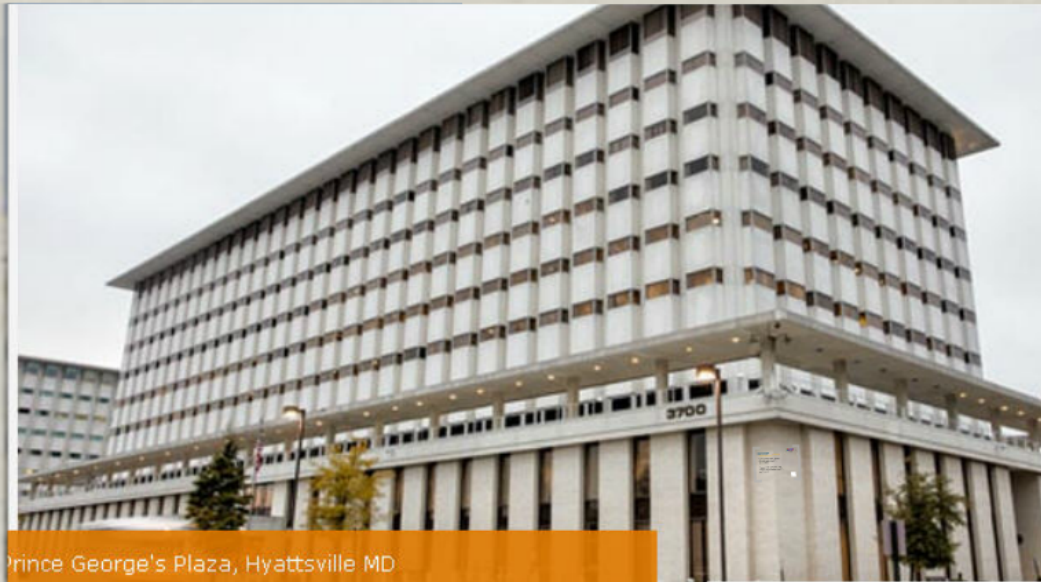

The House passed the Petroleum Homeland Ancillary Resource Trade bill yesterday by a narrow margin of a mere six votes. Reviled by critics as the PHART bill, legislation is intended to boost exports of bio-mass and other natural gas technologies to developing countries in an alleged effort to reduce demand for petroleum from conflict areas such as the Persian Gulf.

The total amount of methane and other volatile energy sources that can be harvested from exported technology is a matter of much debate. The National Energy Bureau published a monograph in 2006 outlining projections over the next ten years.

If everything goes according to plan, one out of every six Aboriginal could power their homes from PHART gas alone. Projections are even more optimistic in nations hardest hit by the war in Iraq such as Kurdistan where energy for transportation must be harvested from the emissions of farm animals.

In countries where petroleum is abundant, such as Iran, the reception



to the PHART initiative has been less than enthusiastic. When interviewed, the current President of Iran simply made a grotesque facial expression and refused to comment any further. 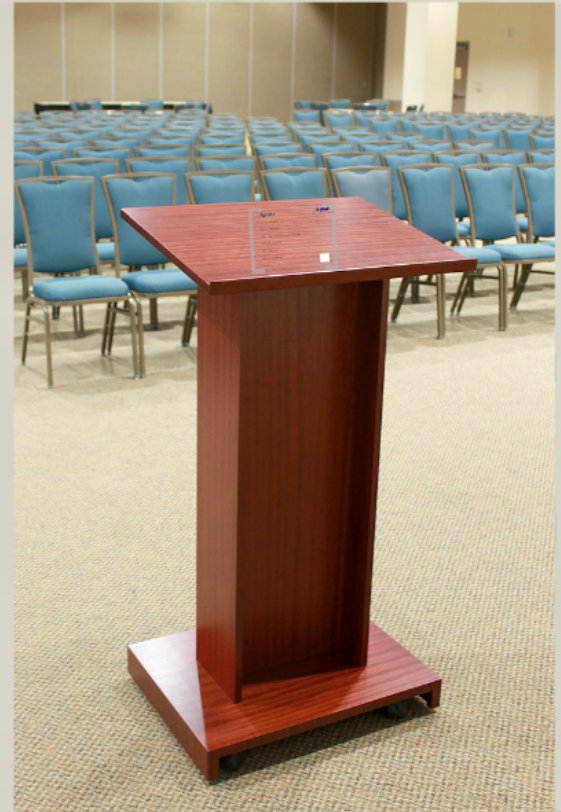

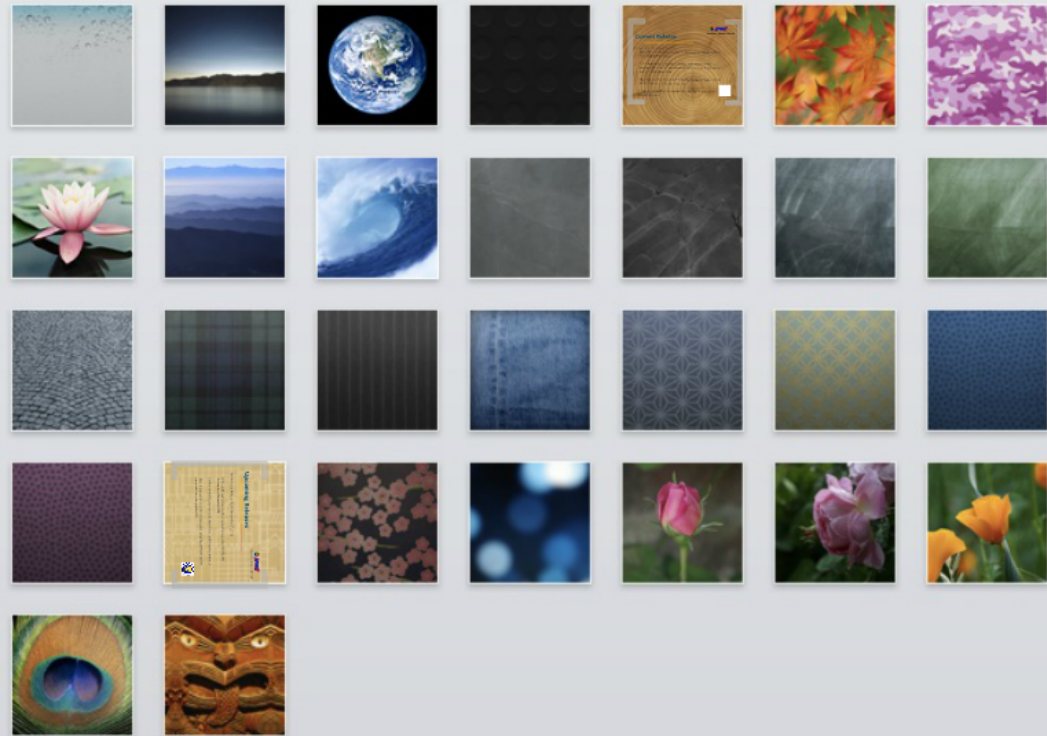

# Current Release

---

Release 12.2 – November 17, 2012

Enable IPAC application to update the databases with Business Event Type Code (BETC) values.

To allow agencies to align with existing budgetary reporting guidelines, IPAC will allow adjustment BETC to be used on Payments and Collection transactions.

Miscellaneous, Description and Obligating Document Number fields will no longer accept special characters.

Updated code for IPAC reports not drop trailing zeros fro agency upload purposes.

Performance Release 12.3 – November 17, 2012

IPAC will begin receiving ALC reference data from the Shared Accounting Module (SAM).

Sender United States General Ledger (SGL) will become optional.

ALC Information and ALC information Download Report will be removed from the application.

Position 1 and 2 = SP (Sub-level profile)  
Position 3 through 5 = ATA (Agency Transfer Allocation)  
Position 6 through 8 = AID (Agency Identifier)  
Position 9 through 12 = BFOA (Beginning Period of Availability)  
Position 13 through 16 = EFOA (Ending Period of Availability)  
Position 17 = A (Account Type)  
Position 18 through 21 = MAIN (Main Account)  
Position 22 through 24 = SUB (Sub-Account)  
Position 25 through 26 = Blank

---

STAR String TAS (current format): No longer used after December 2013

Component TAS: The field is parsed into the various components:

Position 1 and 2 = SP (Sub level prefix)

Position 3 through 5 = ATA (Agency Transfer Allocation)

Position 6 through 8 = AID (Agency Identifier)

Position 9 through 12 = BPOA (Beginning Period of Availability)

Position 13 through 16 = EPOA (Ending Period of Availability)

Position 17 = A (Account Type)

Position 18 through 21 = MAIN (Main Account)

Position 22 through 24 = SUB (Sub-Account)

Position 25 through 26 = blank
