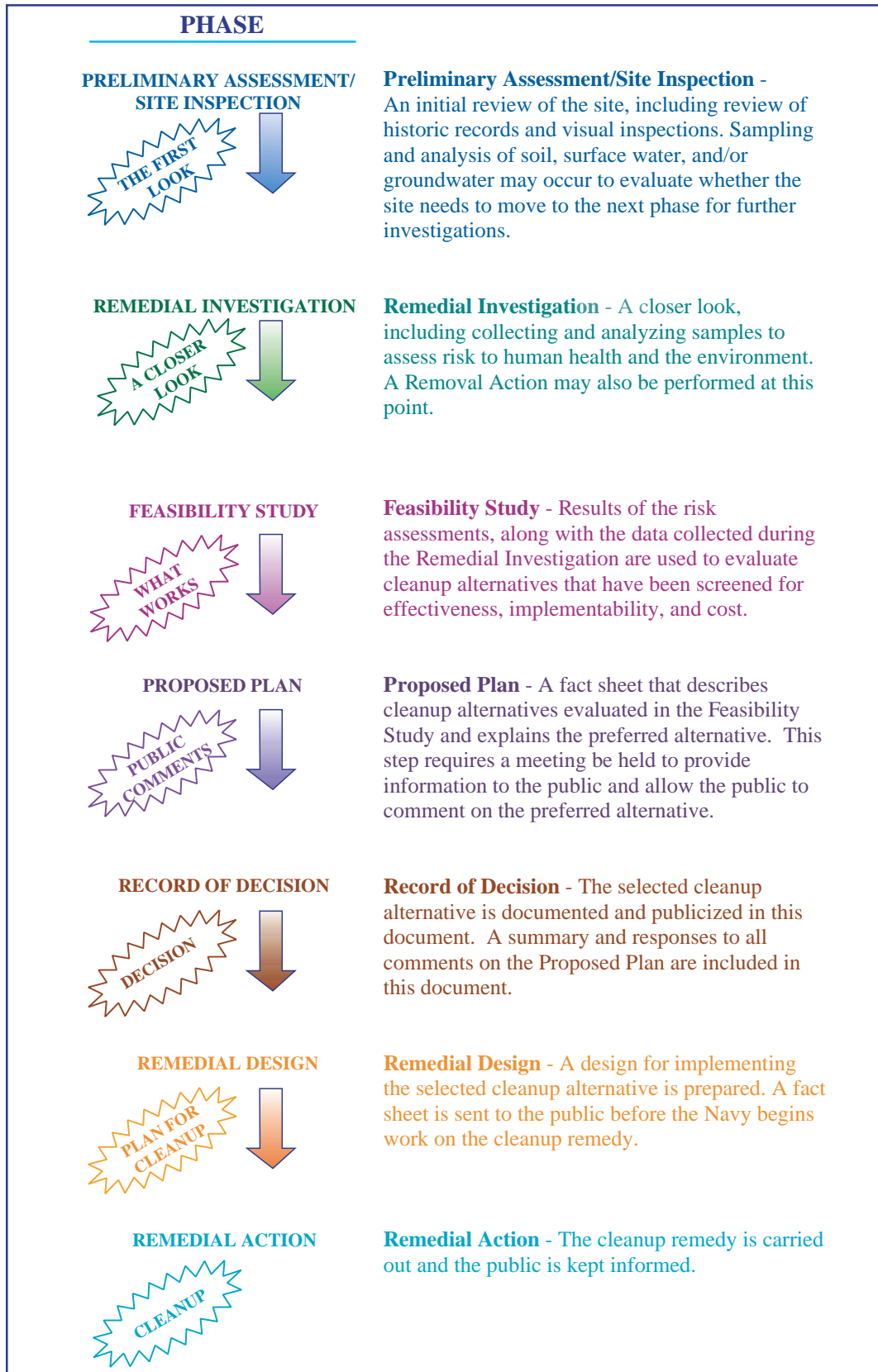


SPECIAL RECOGNITION
