Hypothetical USPS Market Dominant Product Service Standards and Label Lists

PREFACE

This Category 2 library reference provides hypothetical Network Rationalization Service Standard and Label List files that would result if the Area Mail Processing (AMP) consolidation opportunities identified in USPS Library Reference N2012/6 were implemented.

The degree to which service standards will actually change depends upon (a) the outcome of the each of the AMP studies, (b) the amendments to 39 C.F.R. Part 121 that result from the market dominant product service standard rulemaking, and (c) any further modifications that result from consideration of the advisory opinion issued at the conclusion of this docket. Accordingly, the potential changes depicted in USPS Library Reference N2012-1/8 are only illustrative, and are provided solely for the purpose of indicating the nature and magnitude of the service standard changes that could potentially result from the network consolidation plan under review in this docket. The Library Reference should not be interpreted as reflecting that any service change decisions associated with the Request have been made or implemented.
