**CANDIDATE FINANCIAL DISCLOSURE  
EXTENSION REQUEST FORM**

Candidates who are required to file a Financial Disclosure Statement (FD) under the Ethics in Government Act are permitted by federal law to request an extension of up to 90 days, but in no case to a date less than 30 days before an election in which they are a candidate. Filers may request an extension for their FD by filing this form **on or before** the applicable filing deadline. If you have any questions about the due date of your report, contact the Ethics Committee staff at (202) 225-7103. An FD filed under such an extension is not considered late. However, by law, an individual who files a report more than 30 days after it is due without having received an extension must pay a \$200 filing fee. Completed, signed extension request forms must be received by the Ethics Committee on or before the filing deadline. **Extension requests may be delivered by EMAIL to [financial.disclosure@mail.house.gov](mailto:financial.disclosure@mail.house.gov); by FAX to (202) 225-3713; or by MAIL or by HAND to 508 Ford House Office Building, Washington, D.C. 20515. The Committee encourages you to EMAIL or FAX your request if your filing deadline is within the next week to ensure it is received by the deadline.**
