## U.S. Army publishes draft Environment Impact Statement about Fort Benning training land expansion program

FORT BENNING, Ga. – The Army published a Draft Environmental Impact Statement (DEIS) today about the comprehensive study of the impact Fort Benning's Training Land Expansion program may have on local economies and the environment.

The DEIS also identifies a Preferred Alternative for possible land acquisition by the Army.

In June 2010, Fort Benning began investigating the feasibility of purchasing up to 82,800 acres of additional training land to make up for an identified training land shortfall. Since then, Fort Benning officials studied approximately 260,000 acres of land in proximity to the installation in southwest, which included Russell County in Alabama, plus Stewart, Marion, Webster, Harris and Talbot counties in Georgia.

The criteria used in the land study focused on land similar to areas already used for Fort Benning training; land where large commercial timber holdings are located; land adjoining or close to Fort Benning boundaries; and land with the least population density.

Based on preliminary findings and information available to date, land in western and central Stewart County has been identified as the Preferred Alternative for possible land acquisition. Identifying a Preferred Alternative allows resources to be focused in one area. However, the preferred land, called Alternative 3, is one of five alternatives that have been identified. Any of these five alternatives could potentially meet the Army's needs. More data is needed before a final decision can be made.

Studies are ongoing and information is still being collected for the Final Environmental Impact Statement, which will include a more detailed environmental assessment, and a real estate assessment that can only be done by walking the land to determine its suitability for training. Real estate experts will continue to gather information on land ownership and begin to talk with land owners in the study area. In addition, environmental teams will research the presence of possible hazardous waste contamination to the land in the study area. They will also check for the presence of endangered or threatened species.

During the next 45 days, there will be public meetings and opportunities for the public to comment, express concerns and ask questions about the proposed acquisition of land.

Fort Benning officials will host public meetings June 6 to 9. The meetings will be conducted as an "open house," running from 4 to 7 p.m. each day. Guests may drop in any time during the meeting, meet with representatives one-on-one, ask questions and register comments for the record.
