During pioneer days, public facilities such as roads, health care and educational facilities were quite often built by community cooperation. As the population increased our government --with the consent of the total citizenry of the country, set aside public owned land on which to build universities and use the profit from the sale of some of the land or the products from such land to finance the building and operation of such facilities.

These are the true sources of the nation's wealth. New money must be created and issued directly to the elected official, responsible for paying for building and maintaining such facility in the most efficient state.

Elected public officials, from state governors, to school board chairmen must be authorized to apply for new money no interest funding to supplement income from land grants, or to replace such funding procedures.

Building and maintenance districts must be established for health care facilities, similar to those now responsible for transportation and educational facilities.

## APPENDIX E

The following is an outline of a proposed amendment to our constitution to define the procedure for managing the monetary system in a more equitable, efficient and democratic manner. The proposed amendment to the Constitution and following comment to the logic of the proposal specifies an honest equitable and democratic monetary system. It specifies the process by which the wealth creating process must be recognized. Financing such operation must recognizing by the creation and issue of new money to account for the increase national these operations. National infrastructure is the property of the total population. They are not individual personal wealth gains; but that of the total population of the nation.

## AMENDMENT ??

The monetary system of the United States shall consist of a bank accounting , paper certificates and alloy coins.

The monetary standard shall consist of a specified amount of vegetable protein in any non-perishable food grain.

Its issue shall be limited to the accounting for the production of new material wealth commodities, public infrastructure, such as those public facilities and services which we now use as commonly owned and used educational and transportation systems at will without a toll fe for each use. Such facilities are managed as districts in such cases.

To maximize the effectiveness and efficiency of the process higher education in those sciences which conduct training and research in such subjects must also be funded with new money created and issued to the district chairman for paying for all expenses connected with such operations.

## BASIC LOGISTIC OF THE PROPOSED MONETARY SYSTEMS CHANGES.

To complete the process being a democratic nation we must establish health care districts for maximizing the health welfare of the total population of the nation without fee for service or care, as we now use our public highway system and much of our educational system. We must also recognize those new innovations which improve the efficiency of any of the processes or infrastructure design or operations, listed above; must also be recognized by the creation and issue of new money to pay for constructing such enterprises. Stock holder profit making corporation must be limited to the amount of profit they are allowed or they are worker owned, worker managed, profit sharing enterprises. Stockholder corporations gained their financial capital through a fault in current monetary systems which allows them to profit from two sources of financial capital.

New money must be created and used to account for a national monetary reserve.

These forms of national infrastructure increase the productive capacity sufficiently to require new money be created and issued to local operating districts, as their chairman, with authority to secure the support of a majority of the district citizens to secure the issue of such funds. The authority to create and issue such funds for use to pay for the proposed structures and services can be allocated as a devolution program, as is now used to allocate funds for such structures and operations as is done from income from land grants. In addition to road and school districts, a new universal health care system of public health care districts shall be created on the same form and operations to finance public care systems, such facilities to be available for use by all citizens as their health care specialist determines. Access to these services to be available for health care as now is transportation, and educational systems for all through 12 and the best qualified, for specific scientific and engineering through 20 for which there is a reasonable need.

This process eliminates the need to pay interest on such money, the money is created and issued by the authority of our government which is elected to respond to the majority of the citizens wishes. It is therefore a necessity to prohibit stock holder corporations parasite on this system and

receive excessive gains as did some who became known as "Robber Bains," from their greed in managing the use of money generated from implementation of Senator Lot Myrick Morrill's Land Grant Legislation.



**THE FOLLOWING COMMENTS ARE BASED ON A LIST OF MANDATORY AND DISCRETIONARY SPENDING FOR FY '96, BY CONGRESSMAN JIM McDERMOTT, (I received from him on June 8, 1996)**

**Appendix "A" of "A General Theory of Money and Wealth" presents an outline of legislation that extends the concept of land grant funding of schools, roads, and certain other public owned infrastructure, by creating and issue of newly created money to be used without interest for such construction and maintenance. Such structure are public owned and used by the public with paying a service fee. Included in such public support of economic development was the homestead act. mine claim legislation, patent protection, and copyright legislation.**

The following is a comparison of present budget breakdown and that which would occur if the legislation I propose were in effect now.

I have added alphabetical codes to the budget lists, on the left of the listing and the savings in billions implementation of the legislation outlined in Appendix "A" of my book "A General Theory of Money and Wealth.

A. Social Security is not a savings plan, it is a government managed insurance which was originally ment to replace the need for families of those who were unfortunate in their management of their financial affairs to not have accumulated enough savings to give them a minimum income after the were not able to support themselves.

The original plan was to deduct from wages paid to employes of an amount estimated to provide a minimum of sustenance income to those unfortunate enough not to have a sustenance income when they were unable to be employed because of age or disablement. It was not ment to protect the inheritance of their heirs.

The funding of education as a national gain in wealth by the creation and issuing new non-interest bearing money for education and new business startup eliminates the need for saving for heirs.

The current limit in S.S.I. is set at \$62,500, per year, (perhaps congressional income begun at that level) because it was intended to be an an insurance plan not a savings S.S.I. deductions should extend to all incomes not covered by Government of Military retirement plans. This process would make the S.S.I. serve the purpose it was originally intended - provide that no citizen become wards of private charity, or the responsibility of low income heirs.

T. Coded items are military expenses and must be funded by taxes paid by a ratio of percentage of income from all sources according to the benefit received, in maintaining a strong military establishment.

A. Coded items are expenditures for maintaining the unemployed in a level of survival sufficient to maintain a healthy work force reserve, with surplus commodities, from the commodity reserves.

W. Coded items are those activities which maintain the ability of the members of society to improve the wealth producing capacity of the total society and must be supported by the creation and issue of money to be used without interest with which to gain the capability to do so.

W/T coded items contains a mix of minor activities that must be classified according to the criteria defined for (W) or (T) above.

Funding of head start, all levels of education and research by activities predicted to improve the wealth production capacity of the total society must be paid for by the creation and issue of no interest bearing money. The money expended for such activities must remain in circulation to create the savings and loan bank funds for extending the benefits of the increase in wealth these activities extend through the society. New money created and issued to account for infrastructure building and maintenance must be returned to the treasury on a predicted schedule where it must be extinguished to account for the consumption of the facility. The funding shall be limited by the capacity of the availability of unemployed manpower and resources, to be used without interest to pay for such projects predicted to increase the tax income from current levy rates during the first half the predicted service life of the facilities. This process may also be used to payoff existing bonds issued to pay for building and maintaining public owned infrastructure, without applying the payback formula.

Producers of basic commodities by the activities of farming, commercial fishing, mining, and builders of facilities for converting and distributing power developed from energy flow in the environment may draw no interest loans on a schedule predicted to maximize the efficiency of the production activity. The amount of money created and issued to such activity must be limited to one half the market price at the completion of the production cycle. That produce not immediately absorbed by the consumers may be put in the national reserve by the treasury by paying full price of the excess to current needs for a national reserve. The money advanced to the producers must be extinguished as it is returned to the treasury to account for consumption of the commodities. The money created and issued to account for commodities being put into national reserves must stay in circulation until the reserves are sold for consumption at which time the money must be removed from circulation and extinguished to account for consumption of the reserve commodities.

The increase in funding in head start and education will reduce the expenditures of money for prisons, law enforcement, and judiciary departments.

Expenditures for education of the governments in third world countries will increase the capacities of such countries to increase the wealth of their citizens and satisfaction with their economic progress which will encourage the use of family planning and the tendency to reduce economic friction between the have and have-not, countries thus reducing the need for military expenditures at all levels.

The above listed process of funding economic activities switches the creation and issue of new money from those gambling in the stock, commodities, and real estate markets to the direct accounting for the new wealth created by society. This process limits the need to pay the interest we now pay to those who have been given the special privilege of controlling the economy for the benefit of stock holders and gamblers in economic activity. This process limits control of our economy by the approximately 9% of our citizenry who own stock and gamble in the markets and shifts it to the 91% of the citizenry of the country who by the above listed changes in the management of our monetary systems gain control of our economy and the future of their lives.

The plan also funds the buyout of stockholder companies by the employees desiring to create a worker owned, worker managed, profit sharing corporation, with new no interest money

## REQUEST OF THE U.S. CONGRESS

THE SOVEREIGNTY PROPOSAL makes interest free loans of new money to account for new wealth, generated by the following listed activities. It makes new, no interest money available to states, and local governments for funding the building and repair of capital projects, such as roads government owned power generating facilities and school buildings. It also funds head start and education 1 through 12, science, engineering for qualified students through Dr. and basic research projects

The loans may also be used to replace production loans for worker owned worker managed profit sharing producers of basic commodities, innovators and operators of organizations which improves the availability of basic commodities, their combinations and derivatives for consumption.

Under the SOVEREIGNTY PROPOSAL interest free money is created and issued by the United States Government. Article 1, Section B, Clause 5, and loaned directly to individuals responsible for building and repair of public infrastructure, producers of new wealth, and fund education which improves the production of new wealth commodities, thier combinations and derivatives.

When Federal Legislation mandating the SOVEREIGNTY PROPOSAL is properly written and implemented the potential benefit is a tax reduction for individuals, family and businesses. Massive savings in the funding of the building and repair of public owned infrastructure. Paying off bonds of such public owned infrastructure will cause a solid and general improvement in the nation's economy. Therefore I support the concept of the SOVEREIGNTY PROPOSAL, and join in requesting the United States Congress introduce formal legislation as outlined in appendix "A" of the book "A General Theory of Money and Wealth" by Frank Kingen, as necessary to generate national debate. Following such public discussion we can better determine the proposal's full merit and will advise our Representatives and Senators accordingly.
