### **SERVICES PROVIDED:**

#### **APPOINTMENTS: Appointments are made on the last day of the work week starting at 0900.**

All appointments are made no more than one week in advance. The following cases are handled on an appointment basis, for all active duty personnel, retirees, and their family members:

Legal Assistance Attorneys **cannot** provide advice on the following topics: Military Justice Matters, Civilian Criminal Issues, Private Business Activities (including Landlords), Employment Matters (other than USERRA), or Litigation Against the United States

**FAMILY LAW: Clients must attend a briefing prior to consulting an attorney on all pending divorce/separation issues.** The briefing is presented on Thursday at 0730 hrs and again at 1300 hrs—clients must arrive at the appointed time to inprocess before the brief begins. **The Divorce/Separation Brief is limited to the first 25 people and only one spouse may attend the briefing at our office. We do not prepare, review or notarize separation agreements.** Clients may consult an attorney to discuss adoption, paternity, child support/child custody (not related to a pending divorce/separation) and other family-related issues without first attending a briefing on a walk-in basis on Thursdays from 0730-1130 and 1300-1630.

**WILLS/ESTATES PLANNING:** Walk-in will appointments are available every Wednesday at 1300 for Active Duty Service members, accompanying spouses, and deploying DoD Civilian Employees with orders ONLY. Services are limited—we prioritize based on deployment, medical emergencies etc. You must arrive at 1300. Wills are also provided by appointment. Advance life directive (living will), health care powers of attorney, and durable powers of attorney are available on a walk-in basis or in conjunction with an appointment. Living wills allow you to make decisions about life support. Health care powers of attorney allow you to name a person to make medical decisions for you if you become unable to make decisions for yourself. Durable financial powers of attorney allow you to name a person to handle your affairs if you become incapacitated.

**IMMIGRATION/NATURALIZATION:** Clients needing assistance on immigration or naturalization between 1 April and 1 November should schedule an appointment by calling 396-6113/0396 on the last day of the work week. Between November 2 and March 30, clients should contact ACS at 396-6120/8683.

**TAX CENTER:** Open January-June on the 6th floor of Soldier Support Center. Please call 396-8299 for an appointment.

**POWER OF ATTORNEY AND NOTARIAL SERVICES:** Powers of attorney and notarial services are offered on a walk-in-basis at any time during business hours. General powers of attorney and multiple types of specific powers of attorneys are available.
