## Graded Agency:

In FY 2010 the Agency was committed to maintaining its standard of excellence with the utilization of small businesses, while finding innovative ways to address our areas of needed improvement. While we inched closer to attaining the WOSB goal, the HUBZone and WOSB goals remained elusive. Our FY 2011 plan includes actions to specifically address these areas.

## SBA:

The Environmental Protection Agency (EPA) met 3 of its 5 prime contracting goals: Small Business, Small Disadvantaged Business and Service-Disabled Veteran Owned Small Business. However, it did not meet its prime contracting goals for Women Owned Small Business and HUBZone.

Fiscal year 2010 prime contracting achievement saw increases over FY2009 in Women Owned Small Business. EPA FY2010 achievement declined for Small Business, Small Disadvantaged Business, Service-Disabled Veteran Owned Small Business and HUBZone.

EPA regularly attends Small Business Procurement Advisory Council meetings.
