You are hereby informed that the contracts for the Lake Pontchartrain and Vicinity Hurricane Protection Projects, LPV-102.01, Lake Marina Avenue to Orleans Canal levee (W912P8-06-D-0089 Task Order 0001) and LPV-103.01, London Canal to Orleans Canal levee (W912P8-06-D-0089 Task Order 0002) at New Orleans, Louisiana, in Orleans Parish, have been completed by the United States pursuant to Public Law 109-148, Department of Defense, Emergency Supplemental Appropriations Act to Address Hurricanes in the Gulf of Mexico and Pandemic Influenza, 2006.

A joint agency final inspection of the project was conducted on June 9, 2009, and all contract work was found to be satisfactorily complete. Please see the enclosed final inspection attendance roster. The as-built contract drawings were provided to the Orleans Levee District at the final inspection. Please refer to the Levee Owners Manual at www.iwr.usace.army.mil/nfrmp/guidance.cfm as the interim operation and maintenance manual for this project feature. In accordance with the following Project Agreements, Southeast Louisiana Flood Protection Authority – East and Orleans Levee District shall undertake the operation and maintenance, repair, rehabilitation, and replacement (OMRR&R) of this completed project feature of the Lake Pontchartrain and Vicinity, New Orleans, Louisiana, Hurricane Protection Project in Orleans Parish:

- a. Act of Assurance dated effective July 28, 1966, between the United States Government and the Board of Commissioners of the Orleans Levee District for the Lake Pontchartrain and Vicinity, Louisiana, Project, Barrier Plan in Orleans Parish, as amended.
- b. Cooperation Agreement between The United States of America, The Sewerage and Water Board of New Orleans, and The Southeast Louisiana Flood Protection Authority East on behalf of Orleans Levee District, dated February 13, 2007.

In this connection, maintenance is construed as keeping all completed works in working condition to serve the purpose for which they were designed.
