

**High Priority Projects for Surface Transportation Authorization Legislation

Anvil Block Widening	Georgia Department of Transportation	One Georgia Center, 600 West Peachtree Road NW, Atlanta, Georgia 30308	\$3,600,000	<p>Anvil Block Road is a major arterial between a state route and I-675. It is also a major route for the redevelopment of Fort Gillem in Clayton County. The project would widen and reconstruct Anvil Block Road from just east to I-675 to Allen Drive near the Clayton County line. The proposed project will widen Anvil Block Road from two lanes to four lanes. This improvement will result in improved travel conditions, a reduction in travel times along this corridor, and sidewalks for pedestrians.</p>
Veterans Memorial Highway	Cobb County, Georgia	100 Cherokee Street, Marietta, Georgia 30090	\$4,000,000	<p>The proposed project includes Right-of-Way acquisition, preliminary engineering and construction of intersection improvements at Veterans Memorial Highway (US Highway 78/US 278) and Floyd Road/Mableton Parkway, located in southern Cobb County. The project includes realignment of the existing intersection, the addition of a second left-hand turning lane from southbound Floyd Road, to eastbound US 78/US 278, modifications to driveways located on the existing intersection and an improved traffic signal at the intersection. The proposed work will improve overall mobility, and improve conditions for pedestrians and bicyclists.</p>

Rock Quarry Road Improvements	Henry County, Georgia	140 Henry Parkway, McDonough, Georgia 30253	\$4,500,000	<p>The project consists of improvements to Rock Quarry Road in Henry County, from an existing two lane roadway to a four lane roadway with a raised median between Killearn Boulevard and State Route 42/138 (North Henry Blvd). Henry County's Special Purpose Local Option Sales Tax (SPLOST) had a current project for a section of Rock Quarry Road within the above listed limits to construct a four lane bridge over a busy Norfolk Southern Railroad Crossing as well as improving the two lane approach to the bridge on each side.</p>
Butner Road/Stonewall Tell Intersection Improvements	Fulton County, Georgia	141 Pryor Street, Atlanta, Georgia 30303	\$1,120,000	<p>Federal funding will support the completion of construction of improvements to roadway mobility and pedestrian safety to the dangerous five-leg intersection of Butner Road at Stonewall Tell Road in Fulton County. Specifically, funds will support signalization, turning lanes, realignment of approaches, pedestrian facilities, ADA requirements, lighting, curb and gutter, shoulders, access management and drainage. Stonewall Tell and Butner Roads are main two-lane urban minor arterials for South Fulton County with a posted speed limit of 45 mph.</p>

Bouldercrest Road Widening Right-of- Way Acquisition	DeKalb County, Georgia	1300 Commerce Drive, Decatur, Georgia 30030	\$2,000,000	<p>This road improvement project involves additional lanes, safety improvements and sidewalks from I-285 to the Clayton County line. A four lane roadway with a raised median is proposed as part of the project. The north end of the project will tie into a future interchange improvement project at I-285 being designed by the Georgia Department of Transportation. Requested funding will support the right-of-way phase of the project. The project will provide an important link between rapidly growing commercial areas in Clayton County and developing residential areas in DeKalb County. It will also improve access to I-285 for residents in southwest DeKalb County and northern Clayton County.</p>
C-TRAN Bus Acquisition	Clayton County, Georgia/MARTA	2424 Piedmont Road, NE, Atlanta, Georgia 30324-3311	\$3,758,000	<p>Funding will support the replacement of eight clean fuel buses and fourteen paratransit vehicles. The project will allow Clayton County to maintain the bus and paratransit fleet in a good state of repair in order to provide safe, cost efficient and reliable service per the established operations plan for Clayton County transit service. The C-TRAN transit service (bus and paratransit) provides the only means of transportation to and from employment activity centers for 64% of all transit riders within Clayton County.</p>

Davis Road Sidewalk Upgrades	City of Stockbridge	4545 North Henry Blvd, Stockbridge, Georgia 30281	\$800,000	<p>The project would add new sidewalk infrastructure where none presently exists, and it would substantially improve safety for pedestrians by providing a dedicated sidewalk separated from street traffic. Funding would support construction of a minimum six foot wide sidewalk adjacent to Davis Road, beginning at US 23 and ending at Burke Street. The project would add curb and gutter drainage, construct new and/or widened sidewalks, improve signage, signalization, and handicap access, and relocate utilities. Additionally, funding would support the addition of lighting, landscaping, bicycle parking racks, benches, pedestrian shelter, water fountain, parking, and trash receptacles.</p>
Trail Bundle	Cobb County, Georgia	100 Cherokee Street, Marietta, Georgia 30090	\$4,800,000	<p>Funding would support the design, acquisition of right-of-way and construction of trails including the Silver Comet Trail/Atlanta Connector to Fulton County Line and the Six Flags Drive Trail. Each of the projects listed in the bundle are vital to the completion of Cobb County's multi-use trail network, which is anchored by the existing Silver Comet Trail. Additionally, each of the projects enhances safety by providing commuting bicycles alternatives to riding on roadways, and also provide younger riders and elderly and physically limited riders with a safe alternative to riding on roads.</p>
