Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **The two wetland pockets were determined to be isolated wetlands, therefore not jurisdictional wetlands and/or waters of the US. There were four (4) parcels that were evaluated for the presence of wetlands for this project. The lots were located north of Indian River Road and Stumpy Lake. Almost the entire site consisted of uplands. The entire site exhibited hydric soils, which is typical of Virginia Beach and the plant community was a mix of FACW and FACU species side by side, ultimately making up an FAC plant community. There was no strong hydrologic indicators except for the two small isolated wetlands, which had saturated soils in the upper 12-inches and/or standing water in the pit. Wetland A was mostly a depressional area with blackened or water-stained leaves, standing water in pit, and dominated by *Arundinaria gigantea*. Wetland B contained large stands of *Juncus effusus* and *Elmcharis* species and was saturated to the upper 12-inches. There were no ditches present in or around either site that would indicate a connection to WOUS. Therefore, these two wetlands are considered to be isolated, non-navigable, intra-state wetlands.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: 2/7/13-Corps PM conducted a site visit to determine if the isolated wetlands identified and confirmed on the site in May 2006 had changed and/or if any additional wetlands were located on site. The original May 2006 JD expired in May 2011 and the development of the site has not occurred. The current owner, Gibson Development LLC, who was partial owner at that time with the developer to who is named on the original JD, Allen Loree Homes, LLC, has since bought Allen Loree Homes LLC out and is now looking to sell the property to another entity and they have requested a current JD before purchasing. Kerr Environmental Services Corp. (Kerr) contacted the Corps PM regarding the site and asked if a full delineation would be necessary to reconfirm the existing wetland limits. A representative from Kerr conducted a site visit on January 16, 2013 to assess the condition of the wetlands and observed that the two areas of isolated wetlands currently exist on site, appear to have remained the same size, and are located in the same areas as depicted on the drawing entitled "Site Map, Allen Loree Homes, Virginia Beach, Virginia" dated May 23, 2006 and referenced in the original JD letter. The Corps PM told the Kerr representative that a site visit could be conducted first to see if there had been any changes before conducting another full delineation. On February 7, 2013, the Corps PM confirmed that the two small isolated pockets still existed and there did not appear to be evidence of any additional wetlands on the site. Therefore, the Corps PM did not feel it was necessary for another delineation to be conducted, but agreed to issue another approved JD for the isolated wetland delineation.
