Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Approximately 0.70-acres of wetlands were identified on the 5.48-acre parcel located at 544 Baker Road in Virginia Beach, VA. The basis for this delineation includes application of the Corps' 1987 Wetland Delineation Manual and Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Atlantic and Gulf Coastal Plain Region and the positive indicators of wetland hydrology, hydric soils, and hydrophytic vegetation. C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Corps PM conducted a site visit. The wetland delineation was confirmed as flagged in the field and they were determined to be isolated. No evidence of a hydrologic connection to jurisdictional wetalnds and/or waters were identified on the site. An approved jurisdictional determination was issued because the wetlands were deemed isolated. However, the approved JD was not coordinated with EPA per Norfolk District guidance stating that the District is within the 4th Circuit and the Wilson case determined that we cannot assert jurisdiction over isolated wetlands based 33 CFR 323(A)(3). Rapanos guidance only requires coordination under SWANCC.
