## **INTRODUCTION**

### **Purpose**

The information contained in this directory is intended for use, among others, by conformity assessment bodies with clients who are engaged in cross border trade and want conformity assessment results accepted in other countries. The information will help the clients of conformity assessment bodies worldwide to determine how they can effectively gain acceptance of their results in other countries where they do business. The information may also be useful to those conformity assessment bodies that may wish to offer services in countries other than the one in which they are headquartered and accredited.

This directory may contribute to the facilitation of international trade.

Directory entries are provided for national accreditation bodies that responded to a survey conducted in 2004 and are alphabetically ordered by country. Data are given for each accreditation body that may be helpful to conformity assessment bodies to consider a suitable approach to having their conformity assessment results accepted within the country of the accreditation body.

### **Information collection**

Information was obtained by means of a survey using e-mail and the internet. Letters were sent by e-mail to national accreditation bodies inviting them to complete a questionnaire that was posted on a website established for collecting the data. Accreditation bodies and their e-mail addresses were identified using membership lists contained on websites of regional and international groups of accreditation bodies. A few additional accreditation bodies were identified using other sources such as national standards bodies. Data collections took place during the second and third quarters of 2004. The information sought was submitted by respondents using the questionnaire on the website. Accreditation bodies not responding to the initial e-mail request were sent a follow-up request. This process was repeated until non-respondents had received five requests. During this process efforts were made to discover and correct errors in the e-mail addresses being used as well as to locate alternative addresses to contact.

Letters were sent via e-mail to 102 accreditation bodies or alternate sources. In some cases a valid e-mail address could not be verified. In other cases addressees declined to respond. Responses were received from 55 accreditation bodies. Perhaps the publication and distribution of this directory will result in additional submissions being received that can be used for updating the electronic data base. Some of the information submitted has not been reproduced in the directory, and is being used instead to compile statistics reported below to characterize the status of worldwide acceptance of foreign conformity assessment results. It is noted that while not all accreditation bodies have submitted their information, enough did supply information to permit a general indication of current practice.

## Information in the directory entries

Directory entries provide the name of the accreditation body and identify its website URL.

The ISO/IEC documents to which the accreditation body conforms are listed as well as the ISO/IEC documents to which conformity assessment bodies are required to conform.

The numbers of conformity assessment bodies accredited by the accreditation body are given for testing laboratories, calibration laboratories, product certification bodies, personnel certification bodies, ISO 9001 certification/registration bodies, ISO 14001 certification/registration bodies, inspection bodies, and other bodies. The data are given for the total number of accreditations for each type of conformity assessment body. The first column indicates all accredited bodies, both domestic and foreign whether located in-country or outside the country. The second column gives the number of accreditations of foreign conformity assessment bodies located outside the country. For some respondents there was ambiguity in what counted as a foreign conformity assessment body located within the country. In some countries foreign conformity assessment bodies are required to register as domestic entities and therefore do not retain their foreign status.

The data show the number of bodies that have been accredited and are thus an indication of the accreditation body's operational experience.

Contact data for obtaining application information are provided and include contact name, postal and e-mail addresses, telephone and fax numbers, and, when applicable, any language in addition to the national language in which information is also available.

The answer to "Joint assessments and other activities in cooperation with other accreditation bodies" indicates whether an already accredited conformity assessment body might expect to benefit from possible cooperation by the processing accreditation body with the accreditation body responsible for the applicant body's existing accreditation.

Besides relying on accreditation by the national accreditation body as a means for a foreign conformity assessment body's having its results accepted, the conformity assessment body may have additional options available to it. The directory listing for each country indicates the accreditation body's response to whether its national government accepts results from conformity assessment bodies accredited by foreign accreditation bodies.

The last two entries indicate whether the national accreditation body participates in an *international* mutual recognition arrangement and whether the equivalence of the other signatories is recognized in the country, and thus whether the foreign conformity assessment body can rely on its own national accreditation. Information on an accreditation body's participation in *regional* mutual recognition arrangements was not compiled.

## Observations

The documents that specify the requirements that bodies that accredit laboratories, certification (and certification/registration)bodies, and inspection bodies have to meet themselves are: ISO/IEC Guide 58, Calibration and testing laboratory accreditation systems -General requirements for operation and recognition, ISO/IEC Guide 61, General requirements for assessment and accreditation of certification/ registration bodies, and ISO/IEC Technical Report 17010, General criteria for the operation of various types of

bodies performing inspection. Accreditation bodies' responses indicate the prevalence of conformance to these documents:

- 42 of 42 having accredited laboratories indicate conformance to Guide 58.
- 29 of 30 having accredited product certification bodies indicate conformance to Guide 61.
- 20 of 20 having accredited personnel certification bodies indicated conformance to Guide 61.
- 35 of 35 having accredited ISO 9001 certification/registration bodies indicated conformance to Guide 61.
- 31 of 31 having accredited ISO 14001 certification/registration bodies indicated conformance to Guide 61.
- 22 of 27 having accredited inspection bodies indicated conformance to ISO/IEC 17010.

The documents that specify the requirements to be used by accreditation bodies in accrediting conformity assessment bodies are: **ISO/IEC Standard 17025, General requirements for the competence of testing and calibration laboratories**, ISO/IEC Guide 65, General requirements for bodies operating product certification systems, ISO/IEC Standard 17024, Conformity assessment --General requirements for bodies operating **certification of persons**, ISO/IEC Guide 62, General requirements for bodies operating assessment and certification/registration of quality systems, ISO/IEC Guide 66, General requirements for bodies operating assessment and certification/registration of environmental management systems (EMS), and ISO/IEC Standard 17020, General criteria for the operation of various types of bodies performing inspection. **The following summary of survey responses indicates the prevalent usage of these documents:**

- 42 of 42 having accredited laboratories require ISO/IEC 17025.
- 29 of 30 having accredited product certification bodies require Guide 65.
- 18 of 20 having accredited personnel certification bodies require ISO/IEC 17024.
- 35 of 35 having accredited ISO 9001 certification/registration bodies require Guide 62.
- 31 of 31 having accredited ISO 14001 certification/registration bodies require ISO/IEC Guide 66.
- 25 of 27 having accredited inspection bodies require ISO/IEC 17020.

(Note: A small number of accreditation bodies that required these documents are not included in the above data because they had accredited no conformity assessment bodies at the time of the survey.)

Accreditation bodies are expected to accept applications on a non-discriminatory basis and most do. Of the 50 accreditation bodies that are operational, 41 indicated that they accept applications from foreign conformity assessment bodies. Of the 41, 29 indicated they had granted accreditations to foreign conformity assessment bodies outside their country. Of the 9 that gave a non-affirmative response, 3 indicated they did not accept applications from foreign conformity assessment bodies, and 6 gave no response.

ISO/IEC guides for accreditation bodies specify that accreditation fees not be discriminatory. 43 of the 55 responding accreditation bodies indicated they charged the same fees for foreign as for domestic conformity assessment bodies.



It is possible that an accredited conformity assessment body may not have to undergo a complete, possibly redundant, evaluation to obtain accreditation in another country. 39 of the accreditation bodies indicated that their procedures provided for cooperation with other accreditation bodies and only 5 indicated their procedures did not provide for cooperation. 11 did not respond.

It is possible that an accredited conformity assessment body may not have to apply for accreditation in the foreign country. 29 accreditation bodies responded that their governments accepted conformity assessment results from conformity assessment bodies accredited by foreign entities. 19 did not submit a response, possibly indicating a lack of knowledge of government policy. Only 7 responses were negative.

Participation by an accreditation body in a mutual recognition arrangement might facilitate access to that accreditation body by an accredited foreign conformity assessment body. 37 of the responding accreditation bodies indicated participation in a mutual recognition arrangement. 25 were signatories in the arrangement of the International Accreditation Forum, and 28 were signatories in the arrangement of the International Laboratory Accreditation Cooperation.

27 of the 37 have procedures that provide for cooperation with other accreditation bodies; 3 do not, and 6 did not answer.

16 accreditation bodies that are signatories to a mutual recognition arrangement responded that their governments and private sector recognized the equivalence of the other signatories.

30 accreditation bodies that are signatories indicated they have promotion programs to promote this recognition and acceptance of results while 7 do not. Signatories in responding to the question--when do you expect results of the arrangements to be accepted in your country?--answered variously. 3 respondents indicated this had occurred in prior year; 17 respondents indicated 0 years; 14 respondents said it would take 2 to 5 years and 3 indicated more than 5 years. Thus, most respondents indicated acceptance had already taken place or would within 5 years. (Note: a 0 "could mean —now" or could result from a failure to make an entry.)
