- 2. Claim.** Check this box if you overreported amounts only and you would like to use the claim process to ask for a refund or abatement of the amount shown on line 21. Do not check this box if you are correcting ANY underreported amounts on this form.

## Form 941-X: Which process should you use?

### Underreported amounts ONLY

**Use the adjustment process** to correct underreported amounts.

- Check the box on line 1.
- Pay the amount you owe from line 21 by the time you file Form 941-X.

### Overreported amounts ONLY

The process you  
use depends on  
**when** you file  
Form 941-X.

**If you are filing Form 941-X  
MORE THAN 90 days before  
the period of limitations on  
credit or refund for Form 941  
or Form 941-SS expires ...**

Choose either process to correct the overreported amounts.

**Choose the adjustment process** if you want the amount shown on line 21 credited to your Form 941, Form 941-SS, or Form 944 for the period in which you file Form 941-X. Check the box on line 1.

OR

**Choose the claim process** if you want the amount shown on line 21 refunded to you or abated. Check the box on line 2.
