## **Description of the Modification**

The following changes are hereby incorporated into the contract:

- 1. Changes to Section C, "Statement of Work":
  - a. Part C.3 "Interactions with WTP Contractor," paragraph (b)(1)(vii) is changed as follows:
    - i. Delete "DOE Order 430.1A Life Cycle Asset Management"
    - ii. Replace with "DOE Order 413.3 Program and Project Management for the Acquisition of Capital Assets and DOE Manual 413.3-1 Project Management for the Acquisition of Capital Assets. (M055)"
  - b. Part C.6, Standard 1, paragraph (c)(1) "Project Control System Definition" is changed as follows:
    - i. Replace the entire paragraph with:

"Project Control System Definition: The Contractor shall establish, maintain, and use a Project Control System that supports successful execution of the WTP Project during all activities (e.g., transition, design, construction, and commissioning). The System must produce accurate planning, budgeting, reporting, and change control data and meet the intent of the requirements of the RPP Project Management Plan. In addition, the system will meet the requirements of DOE Order 413.3 Program and Project Management for the Acquisition of Capital Assets and DOE Manual 413.3-1 Project Management for the Acquisition of Capital Assets. The Contractor shall provide all necessary technical information and support related to the WTP Project to enable DOE to proceed with the critical decision process (DOE Order 413.3 and DOE Manual 413.3-1) and to enable DOE to meet the data requirements of the integrated planning, accountability, and budgeting system. The Contractor shall also support ORP in developing and maintaining the integrated RPP Baseline. In the event there is a conflict between any terms and conditions in this contract and DOE O 413.3 and DOE M 413.3-1, then the Order and Manual will govern. (M055)"

- c. Part C.6, Standard 1, paragraph (d)(2)(A)(iv) is changed as follows:
  - i. Delete "DOE Order 430.1A" and replace with "DOE Order 413.3 and DOE Manual 413.3-1."
  - ii. Insert (M055) at the end of the paragraph.
- 2. Changes to Section J, "List of Attachments", Attachment E, section (b) table:

- a. Delete "DOE O 430.1A 10/14/98 Life-Cycle Asset Management" and replace with "DOE O 413.3 1/3/05 Program and Project Management for the Acquisition of Capital Assets"
- b. Following the entry for DOE O 413.3, insert the following table entry: DOE M 413.3-1 3/28/03 Project Management for the Acquisition of Capital Assets."
- 3. There are no adjustments to any of the terms and conditions in Section B and Section F of the contract related to this modification.
