Purpose of Modification:

The purpose of this modification is to obligate incremental funding and update the table in Section B, *Supplies or Services and Prices/Costs*, Contract Clause B.2, *Obligation and Availability of Funds and Contract Value*, paragraph (a).

Description of Modification:

1. The total amount of funds obligated to budgetary control point 1111245 is increased by \$24,000,000.00 from \$835,670,799.00 to \$859,670,799.00
2. The total amount of funds obligated to budgetary control point 1111241 is increased by \$13,000,000.00 from \$255,530,590.00 to \$268,530,590.00.
3. The total amount of funds obligated to budgetary control point 1111244 is increased by \$16,000,000.00 from \$499,649,971.00 to \$515,649,971.00
4. The total amount of funds obligated to budgetary control point 1111243 is increased by \$1,000,000.00 from \$64,000,000.00 to \$65,000,000.00
