A. The purpose of this modification is to incrementally fund CLIN 02 of the contract in the amount of \$866,000.00. As a result of this modification the total obligated funds for CLIN 02 for the Tank Farms Project is changed from \$9,707,195.30 to \$10,573,195.30.

B. ORP anticipates this funding to be sufficient for continued operations of the 222-S Laboratory through December 11, 2010.
