#### About USDA's National Agricultural Statistics Service (NASS)

In 1791, President George Washington, spurred by an inquiry, wrote to several farmers requesting information on land values, crops, yields, livestock prices, and taxes. It was, in effect, the Nation's first documented agricultural survey. In 1862, President Abraham Lincoln founded the United States Department of Agriculture (USDA), and one of its original missions was the dissemination of information about U.S. agriculture. One year later, the first USDA statistical report was released.

Today, the USDA's National Agricultural Statistics Service (NASS) conducts hundreds of surveys every year and prepares reports covering virtually every aspect of U.S. agriculture. Production and supplies of food and fiber, prices paid and received by farmers, farm labor and wages, farm finances, chemical use, and changes in the demographics of U.S. producers are only a few examples.

#### **Census Introduction**

The responsibility for conducting the agriculture census program was transferred from the Bureau of Census to NASS by the 1997 Appropriations Act. The Census of Agriculture, Census of Aquaculture, Census of Horticultural Specialties, and the Census of Farm and Ranch Irrigation were included in the census program. The 1997 Census of Agriculture was the first census program conducted by NASS.

The census of agriculture program was undertaken to obtain agricultural statistics for each county and state, and for the nation as a whole. It has become the leading source of statistics on the nation's agricultural production and the only source of consistent, comparable data at the county, state, and national levels. In 1976, Congress authorized the adjustment of the data reference year for the Census of Agriculture so that it coincided with other government economic censuses. This adjustment in timing established the agricultural census on a 5-year cycle collecting data for years ending in 2 and 7.

The "Census of Agriculture Act of 1997," Public Law 105-113 (Title 7, United States Code, Section 2204g), made changes in the census of agriculture program. The law directed the Secretary of Agriculture to conduct a census of agriculture in 1998 and every fifth year after, covering the prior year. All states, Puerto Rico, Guam, the U.S. Virgin Islands, and the Commonwealth of the Northern Mariana Islands were included in the census of agriculture program.

#### Users of NASS Data

Producers, farm organizations, agribusinesses, lawmakers, and government agencies all rely heavily on the information produced by NASS.

The smooth operation of Federal farm programs depends on accurate statistical information on acreage, production, stocks, prices, and income, as well as the planning and administration of related Federal and State programs in areas such as consumer protection, conservation and environmental quality, trade, education, and recreation.

Regular updating of information helps to ensure an orderly flow of goods and services among agriculture's producing, processing, and marketing sectors. Reliable, timely, and detailed crop and livestock statistics help to maintain a stable economic climate and minimize the uncertainties and risks associated with the production, marketing, and distribution of commodities.

Farmers and ranchers rely on NASS reports in making production and marketing decisions such as how much corn to plant, how many cattle to raise, and when to sell.

The transportation sector, warehouse and storage companies, banks and other lending institutions, commodity traders, and food processors rely heavily upon NASS estimates and forecast for their activities. Those in agribusiness who provide farmers with seeds, equipment, chemicals, and other goods and services study the reports when planning their marketing strategies.

Analysts transform the statistics into projections of coming trends, interpretations of trends, economic implications, and evaluations of alternative courses of action for producers, agribusinesses, and policy makers.

#### **Brief Description of NASS Survey and Census Programs**

NASS surveys provide primary sample source data about specific areas of the nation's agricultural economy. In contrast, NASS censuses provide detailed county level data for the over 3,200 counties in the United States as well as Puerto Rico. Sample survey data and census data are edited, analyzed, processed, and summarized. Most responses by individuals and businesses to survey questions about their operations are voluntary except for the responses to Peanut Stocks and Processing Surveys, Dairy Product Prices Surveys, Cotton Ginning Surveys, and Census programs, which are all mandatory. Processed survey input/source data, observations, comments, and other factors such as weather are statistically improved to produce estimates and forecasts. These relate to land use, production volume, production cost versus price received, commodity stocks, distribution, losses, prices received, farm labor, and other economic factors. Surveys and censuses are conducted by: a) mailed questionnaires, b) personal and telephone interviews, c) computer assisted telephone interviews (CATI), d) computer assisted personal interviews (CAPI), and e) electronic data reporting (EDR) online.

Special surveys may be made only once but most surveys are periodic. The following describe briefly a few major types of surveys conducted:

- Objective Yield Surveys are conducted monthly during the crop growing seasons and involve
  personal interviews of farm operators, as well as observations and plant related
  measurements of randomly selected sample plots. The national objective yield surveys
  primarily include corn, cotton, soybeans, wheat, and potatoes. Other crops covered in
  individual states include grapes (raisins), almonds, oranges (Navel and Valencia), and
  walnuts in California; citrus fruits in Florida; and hazelnuts in Oregon. The purpose of
  objective yield surveys is to provide:
  - Counts and measurements that are used to forecast or estimate crop yield per acre.
  - Counts and weights of the crop left in the field or orchard after harvest to estimate harvesting losses per acre.
  - Changes in acreage intended for harvest based on the plowing up or destruction of sample fields before harvest.
- The June Area Survey is conducted annually and designed to account for every acre of land, all agricultural activities, and land uses within segment boundaries. Survey data collected includes crop acreage, genetically modified crop acreage, grain stocks, inventories of cattle, hogs, sheep, goats, and poultry as well as land values, cash rents, farm numbers, and value of sales data. The diverse range of items is needed for direct estimation requirements and sample design needs for projects conducted later in the survey year.
- The Farm Labor Survey is conducted quarterly by mail, personal interviews, and computer
  assisted telephone interviews with farm operators or agricultural service firms and with
  electronic data reporting by farm operators or agricultural service firms. It provides timely
  data on wage rates and estimates of agricultural laborers employed at the state, regional, and
  national level.

- Agricultural Surveys (AS) combine several probability survey questionnaires into one survey.
  These surveys are generally conducted quarterly but may be conducted as frequently as
  once a month and are designed to reduce the reporting burden on respondents while
  collecting needed data in a timely manner. The type of survey data collected is dependent on
  the state and whether the survey data are collected by mail, personal interviews, computer
  assisted telephone interviews, or with electronic data reported online by respondents.
- The Agricultural Resources Management Survey (ARMS) is conducted annually to collect
  production practices and cost of production data on selected commodities. ARMS also
  collects detailed whole farm financial information from a representative sample of farms and
  ranches across the country. ARMS data are collected in three data collection phases:
  - Phase I: A screening survey that collects general farm data such as crops grown, livestock inventory, and value of sales by mailed questionnaires, CATI, and EDR.
     Screening data are used to qualify (or screen) farms for the other two phases of ARMS.
  - O Phase II: A survey that collects data associated with agricultural production practices, resource use, and variable costs of production for specific commodities by personal interview. Up to five commodities are surveyed on a predetermined rotation in a given year. Farm operators provide data on fertilizer and nutrient applications, pesticide applications, pest management practices, and irrigation.
  - Phase III: A survey collected by personal interview with farm operators. Data on farm operating expenditures, capital improvements, assets, debt for agricultural production, data on farm-related income, government payments, the source and amount of off-farm income, as well as demographic characteristics of the household are collected.
- Census of Agriculture is conducted every 5 years (in years ending in 3 and 8) and covers the preceding year. The census is designed to obtain data on a comprehensive list of commodities. Census questionnaires are designed with open-ended questions to allow respondents to report every item produced on the farm, even the rarest of commodities. The census also collects information on expenses and income from all sources, operator characteristics such as race, gender, age, tenure on the farm, and operating arrangement. The Census of Agriculture is conducted in all 50 states and targets all farms and ranches selling or intending to sell \$1,000 or more of agricultural products including horticulture. A Census of Agriculture is also conducted in Puerto Rico on farms with \$500 or more in sales and intentions.
- Census of Aquaculture is conducted every 5 years in the third year after each 5 year Census of Agriculture on a target population identified from the preceding Census of Agriculture. The Census of Aquaculture covers aquaculture practices, operation size, production, sales, sources of water, marketing channels, and aquaculture for restoration and conservation purposes.
- Census of Horticultural Specialties is conducted two years after every other 5 year Census of Agriculture, or every 10 years. The target population is identified from the preceding Census of Agriculture. The Census of Horticultural Specialties covers bedding plants, herbaceous perennials, potted plants, cut flowers, foliage plants, deciduous trees, and other nursery plants. It also includes turf grass, mushrooms, greenhouse food crops, seeds, and Christmas trees. Data on producing area, sales, marketing channels, irrigation practices, production expenses, and labor are also obtained.
- Census of Farm and Ranch Irrigation, also known as the Farm and Ranch Irrigation Survey (FRIS), is conducted every 5 years in the year following the Census of Agriculture. The target population is identified from the preceding Census of Agriculture. The Census of Farm and Ranch Irrigation provides detailed data relating to on-farm irrigation activities which are used to prepare a wide variety of water-related programs, economic models, legislative initiatives, market analysis, and feasibility studies.
