#### 1.0 INTRODUCTION

#### 1.1 Purpose

Occupational Safety and Health Administration (OSHA) standards 29 CFR 1910.151 (c), and 29 CFR 1926.50 (g) [*MEDICAL SERVICES AND FIRST AID*] require provision of suitable facilities for quick drenching or flushing of the eyes and body when employees may be exposed to injurious corrosive materials. Through the General Duty Clause of OSHA (Public Law 91-596), the CH2M HILL Plateau Remediation Company (CHPRC) applies consensus standard ANSI Z358.1 (*EMERGENCY EYEWASH AND SHOWER EQUIPMENT*) for planning, design, construction, alteration, and acquisition specifications. The project/facility Occupational Safety and Industrial Hygiene organization may be consulted with for issues relating to this subject area that are not directly addressed by this document.

#### 1.2 Scope

This procedure includes the following types of equipment:

- Plumbed and self-contained showers.
- Plumbed and self-contained eyewash equipment.
- Eye/Face wash equipment.
- Hand-held drench hoses.
- Combination units.

Personal eyewash devices (e.g., squeeze bottles) which are used solely as supplementary support to plumbed and/or self-contained units, and decontamination showers/units, are excluded from the scope of these requirements.

#### 1.3 Applicability

This procedure is applicable to CHPRC Team employees and subcontractor personnel involved with the application, maintenance and use of chemicals.

#### 1.4 Implementation

This procedure is effective upon publication.

All responsibilities associated with this procedure are identified in the process steps.

#### 3.0 PROCESS

Actionee	Step	Action
All Personnel	1.	MAINTAIN a clear path of travel to equipment stations.
	2.	MAINTAIN the area around equipment stations to be free of obstructions.
Line Management	3.	INSPECT <u>AND</u> ACTIVATE plumbed units weekly for a period long enough to VERIFY proper operation <u>AND</u> ENSURE design performance is maintained.
	4.	INSPECT all eyewash and shower units annually to ASSURE conformance with ANSI Z358.1, Section 5.
	5.	PROTECT equipment that may be exposed to cold weather temperatures from freezing.
	6.	PROTECT where accumulation of airborne contaminants may deter proper fluid flow or operation, nozzles of plumbed and self-contained eyewash equipment, and eye/face wash equipment.
	7.	FOLLOW the design specifications of ANSI Z358.1 for installations of plumbed emergency eyewash and shower equipment, or in the provision of portable units.
	8.	AVOID confusion in operating technique during an emergency by uniformity in equipment type and style selection for multiple installations.
	9.	ASSEMBLE <u>AND</u> INSTALL equipment in accordance with manufacturer instructions.
	10	. PROVIDE suitable facilities in the work area for immediate emergency use for quick drenching or flushing of the eyes and body where any person may be exposed to injurious corrosive materials.
	11	. INSTALL <u>OR</u> PLACE equipment in well-lit, easily reachable locations to PROVIDE accessibility within a 10 second time frame, on the same level as the hazard and the path of travel shall be free of obstructions that may inhibit the immediate use of the equipment.
	12	. IDENTIFY emergency eyewash and shower stations using a highly visible sign. Lights are an acceptable means for identification of installations completed prior to April 6, 1989, but are not recommended as the sole means for identification.

		<ol> <li>INSTRUCT affected employees in the location and proper use of the emergency eyewash and shower equipment located in their work areas.</li> </ol>
Employees		<ol> <li>INSPECT <u>AND</u> MAINTAIN emergency shower and eyewash equipment <u>AND</u> POSSESS an adequate knowledge of manufacturer performance instructions.</li> </ol>
Line Management		<ol><li>PROVIDE a water supply that is tepid/lukewarm in temperature for plumbed units installed after April 16, 1998.</li></ol>
NOTE:	<b>NOTE:</b> Delivered water temperature for existing installations should not be at extremes would reasonably be expected to prevent an employee from fully flushing the a area(s) as a result of undue discomfort. The 2004 date reflects the publication revised ANSI Z358.1 Standard. With this revision, ANSI has defined "tepid/lukewarm" to mean not higher than 38° C (100° F) and not lower than 15 (60° F).

	1	<ol> <li>USE manufacturer instructions, where applicable, in developing specific maintenance, inspection, and testing criteria.</li> </ol>
	1	<ol> <li>MAINTAIN shutoff valves installed between the sanitary water supply and the plumbed equipment in an "open" position during the performance of those work activities which require availability of emergency eyewash or shower equipment.</li> </ol>
NOTE:		d and self-contained eyewash equipment should be capable of delivering fluid to the eyes not less than 1.5 liters per minute (0.4 gpm) for at least ites.
