The Rural Alaska Community Action Program (RurAL CAP) would like to summarize work completed under the NMFS Purchase Order HA 133F09SE3945 through January 29, 2010.

Under the conditions of our contract, we agreed to and have provided the following:

- 1. Meeting room and teleconference facilities for one or more meetings per contract year in a mutually agreed upon place and time between NMFS, Alaska Regional staff or other State/Federal personnel, and ANSHWG and facilitate consultation between NMFS and ANSHWG on:
 - a. Implementation of regulations
 - b. Development of cooperative agreements
 - c. Overall implementation of the subsistence halibut program
- 2. Airfare and travel support to persons who could effectively contribute to the subsistence discussion
- 3. Summary report of meetings including dates, attendees, agenda, and a synopsis of key points
- 4. Assist NMFS with compliance of Executive Order 13175.
- 5. Work with ANSHWG attendees and others to demonstrate that they represent Alaska Native tribes affected by halibut subsistence regulations.
- 6. Serve as a liaison between ANSHWG and NMFS.

Work completed includes preparation and hosting a Working Group meeting December 11, 2009 in Anchorage, assisting in creating the meeting agenda and compiling meeting packets,

Re: North Pacific Fisheries Management Council structure

Dear Senator Murkowski,

The Alaska Native Subsistence Halibut Working Group (ANSHWG) requests assistance in obtaining amendments to the Magnuson-Stevens Fisheries Management and Conservation Act (MSA) related to the composition of the North Pacific Fisheries Management Council (NPFMC). The NPFMC, in conjunction with the National Marine Fisheries Service (NMFS), is responsible for decision making on a variety of important issues that impact Native subsistence users in Alaska. As such, it is critical that the concerns and views of Alaskan Native subsistence users are part of the decision making process, on par with that of the commercial fishing industry that currently dominates the NPFMC structure.

The ANSHWG is sponsored by the NMFS in an attempt to fulfill the mandate by Executive Order 13175, which established requirements for regular and meaningful consultation and collaboration with tribal officials in the development of Federal policies that have tribal implications to strengthen the United States' government-to-government relationships with Indian tribes. While ANSHWG continues to give input during the NPFMC process, we are concerned that subsistence users face serious disadvantages when dealing with the NPFMC process. The NPFMC has initiated a rural outreach program to help with this problem and provide rural residents an opportunity to comment on proposed actions. The ANSHWG feels that improved outreach and tribal consultation will not fully solve this problem.

The views of Native Alaskans need to be part of the NPFMC process, in the form of voting seats, positions on advisory panels, government-to-government tribal consultation, participation on workgroups, outreach meetings and public comments. The voting members of the NPFMC do consider recommendations from advisory panels, workgroups and public comments, but they are not bound by any recommendations they offer to the NPFMC. The only way to ensure that the interests of Native Alaskans are fully considered is to establish Native Alaskan voting seats on the NPFMC. These seats will allow Native Alaskans to offer their unique input during all phases of the NPFMC decision making process, thus improving the NPFMC's management of these important fisheries resources.

The ANSHWG is therefore formally requesting your assistance in obtaining tribal representation on the NPFMC in the form of four voting seats through an amendment to the Magnuson-Stevens Act. We propose that these seats be given to representatives of Alaskan federally recognized tribes and/or Alaska Native organizations. Any nominees for these seats should not be directly employed by a Community Development Quota program or the pollock industry.

The meeting was called to order at 9:15 am. David O. David started the group off in prayer and A moment of silence was taken in memory of Teddy Kugchun, an ANSHWG member who passed away this year.

Introductions were made by committee members.

Cycle of Chair Election

A motion was made to retain the present Chair, Iver Malutin, and to begin another two-year cycle next year. All approved. There was discussion about electing a group secretary to take minutes. The group is satisfied with RurAL CAP staff continuing to take minutes. No group secretary was elected.

Halibut Regulatory Actions Published by NMFS

Jay Ginter gave an update of the newest regulatory actions. His handout was titled, "Current Regulatory Projects for Halibut Fisheries: 12/4/09." Most relevant was the Rural Resident Definition, which became effective 12/4/09, which defines new areas outside of existing rural communities in which a resident would qualify for subsistence halibut fishing.

NOAA Enforcement of Halibut Regulations

Ron Antaya, provided an update on the Enforcement division's activities over the past year, noting that there is a new commissioner for that agency, and that they are stepping up efforts by doing outreach in order to prevent violation of halibut regulations.

<u>Regulatory Proposals submitted for Council Consideration</u>
Jane DiCosimo distributed a draft of 14 IFQ Implementation Team Motions to

change regulations, of which 7 proposals were approved for consideration. None were subsistence related. Jane also described plans for a new outreach program NPFMC is developing in regards to salmon bycatch to advise about rural issues. **Lunch Break**

Results of Latest Survey of Subsistence Halibut Harvests

Jim Fall showed a PowerPoint presentation regarding subsistence harvests numbers. Among the discussion points were how to enhance the registration process, a comparison of tribal and rural harvests, results of surveys, and reasons for the drop in number of SHARC holders.

Mike Miller introduced a motion to send a letter to the NMFC thanking them for NPFMC funding, and to request continued funding. All were in favor. Motion passed.

Mike Sloan made a motion to write a letter to Alaska senators to change the Magnuson-Stevens Act in order to establish four voting seats on the North Pacific Fishery Management Council. All were in favor. Motion passed.

Halibut Stock Assessment Outlook

Gregg Williams gave a report on his commission's work in the Alaska region. He showed a PowerPoint regarding the 2009 Pacific Halibut Assessment. The average weight as well as average age of halibut is dropping each year.

Monitoring Sport Charter Harvests of Halibut

Jay Ginter described how the state analyzes halibut harvests by sport charters: logbooks, postcards to clients, statewide surveys, etc. He distributed a handout titled, "Summary of ADF&G Charter Logbook Halibut Data Evaluation, 2006-2008," prepared by Scott Myer of ADF&G Sport Fish.

Discuss Salmon/Halibut Bycatch Issues

There was a lengthy discussion on whether to expand the ANSHWG scope beyond halibut, however, after weighing the pros and cons, the group decided not to change since the group is working so well as it is. Mike Miller made a motion, seconded by Carrie, to revisit bycatch caps. All were in favor. Motion passed.

RurAL CAP Update

Rebekah Luhrs gave an update the group on funds remaining in the ANSHWG budget.

Date for Next Meeting

It was decided to let the Chair determine the next time of the meeting. The meeting adjourned at 4:45 pm.
