ORDER INSTITUTING ADMINISTRATIVE PROCEEDINGS PURSUANT TO SECTION 15(b) OF THE SECURITIES EXCHANGE ACT OF 1934, MAKING FINDINGS, AND IMPOSING REMEDIAL SANCTIONS

I.

The Securities and Exchange Commission ("Commission") deems it appropriate and in the public interest that public administrative proceedings be, and hereby are, instituted pursuant to Section 15(b) of the Securities Exchange Act of 1934 ("Exchange Act") against Steven T. Kobayashi ("Respondent").

II.

In anticipation of the institution of these proceedings, Respondent has submitted an Offer of Settlement (the "Offer") which the Commission has determined to accept. Solely for the purpose of these proceedings and any other proceedings brought by or on behalf of the Commission, or to which the Commission is a party, and without admitting or denying the findings herein, except as to the Commission's jurisdiction over him and the subject matter of these proceedings, and the findings contained in Section III.2 below, which are admitted, Respondent consents to the entry of this Order Instituting Administrative Proceedings Pursuant to Section 15(b) of the Securities Exchange Act of 1934, Making Findings, and Imposing Remedial Sanctions ("Order"), as set forth below.

III.

On the basis of this Order and Respondent's Offer, the Commission finds that:

- 1. Kobayashi, 39, resides in Livermore, California. From August 2004 through September 2009, Kobayashi was a registered financial adviser at UBS Financial Services, Inc.'s Walnut Creek, CA branch office. He holds Series 7, 63 and 65 licenses. Kobayashi also established and managed TNK Financial, LLC and STK Financial, LLC, two California limited liability companies through which he made investments outside of the UBS portfolio. From 2005 through 2009, through TNK Financial, LLC, Kobayashi managed Life Settlement Partners, LLC ("LSP"), a California-based pooled investment fund which invested in life settlement policies.
- 2. On April 26, 2011, a final judgment was entered by consent against Kobayashi, permanently enjoining him from future violations of Sections 10(b) and 15(a) of the Exchange Act and Rule 10b-5 thereunder, in the civil action entitled Securities and Exchange Commission v. Steven T. Kobayashi, Civil Action Number 11-cv-00981-CW, in the United States District Court for the Northern District of California, Oakland Division.
- 3. The Commission's complaint alleged that, in connection with the sale of securities, Kobayashi, a registered representative, misappropriated funds from his UBS clients' accounts. The complaint further alleged the Kobayashi misappropriated millions of dollars from LSP, for which he served as manager. The complaint also alleged that Kobayashi acted as an unregistered broker-dealer by selling interests in LSP.

IV.

In view of the foregoing, the Commission deems it appropriate and in the public interest to impose the sanctions agreed to in Respondent Kobayashi's Offer.

Accordingly, it is hereby ORDERED:

Pursuant to Section 15(b)(6) of the Exchange Act that Respondent Kobayashi be, and hereby is barred from association with any broker, dealer, investment adviser, municipal securities dealer, municipal advisor, transfer agent, nationally recognized statistical rating organization, and from participating in the offer of any penny stock including: acting as a promoter, finder, consultant, agent or other person who engages in activities with a broker, dealer or issuer for purposes of the issuance or trading in any penny stock, or inducing or attempting to induce the purchase or sale of any penny stock. Any reapplication for association by the Respondent will be subject to the applicable laws and regulations governing the reentry process, and reentry may be conditioned upon a number of factors, including, but not limited to, the satisfaction of any or all of the following: (a) any disgorgement ordered against the Respondent, whether or not the Commission has fully or partially waived payment of such disgorgement; (b) any arbitration award related to the conduct that served as the basis for the Commission order; (c) any self-regulatory

organization arbitration award to a customer, whether or not related to the conduct that served as the basis for the Commission order; and (d) any restitution order by a self-regulatory organization, whether or not related to the conduct that served as the basis for the Commission order.
