ORDER INSTITUTING PROCEEDINGS AND NOTICE OF HEARING PURSUANT TO SECTION 12(j) OF THE SECURITIES EXCHANGE ACT OF 1934

I.

The Securities and Exchange Commission ("Commission") deems it necessary and appropriate for the protection of investors that public administrative proceedings be, and hereby are, instituted pursuant to Section 12(j) of the Securities Exchange Act of 1934 ("Exchange Act") against Respondents Cabot Medical Corp., CacheStream Corp., Cadema Corp., Cannon Express, Inc., Capfilm, Inc., Capita Research Group, Inc., Capital Appreciation Plus LP I, Capital Dome, Inc., and Caredata.com, Inc.

II.

After an investigation, the Division of Enforcement alleges that:

A. RESPONDENTS

1. Cabot Medical Corp. (CIK No. 719073) is a New Jersey corporation located in Langhorne, Pennsylvania with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Cabot Medical is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-Q/A for the period ended April 29, 1995, which reported a net loss of \$64,000 for the prior three months.

- 2. CacheStream Corp. (CIK No. 1110038) is a dissolved Colorado corporation located in Duluth, Georgia with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). CacheStream is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-QSB for the period ended June 30, 2001, which reported a net loss of \$600 for the prior three months.
- 3. Cadema Corp. (CIK No. 318951) is a Delaware corporation located in Norwalk, Connecticut with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Cadema is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-QSB for the period ended September 30, 2002, which reported a net loss of \$22,469 for the prior nine months. As of September 15, 2008, the company's common stock (symbol "CIBM") was quoted on Pink OTC Markets, Inc. ("Pink Sheets"), had nine market makers and was eligible for the piggyback exception of Exchange Act Rule 15c2-11(f)(3). The company's Convertible Preferred Series A 8% Cumulative Preferred stock (symbol "CIBMP") was quoted on the Pink Sheets, had three market makers, and was eligible for the piggyback exception of Exchange Act Rule 15c2-11(f)(3).
- 4. Cannon Express, Inc. (CIK No. 801558) is a void Delaware corporation located in Springdale, Arkansas with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Cannon Express is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-Q for the period ended March 31, 2003, which reported a net loss of over \$3 million for the prior three months. On December 9, 2003, Cannon Express filed a Chapter 11 petition in the U.S. Bankruptcy Court for the Western District of Arkansas, and the case was closed on June 30, 2004. As of September 15, 2008, the company's common stock (symbol "CEXP") was traded on the over-the-counter markets.
- 5. Capfilm, Inc. (CIK No. 788845) is a Delaware corporation located in Lee, Massachusetts with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Capfilm is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-KSB for the period ended December 31, 1993, which reported a net loss of \$512,986 for the year ended 1993. As of September 15, 2008, the company's common stock (symbol "CAPF") was traded on the over-the-counter markets.
- 6. Capita Research Group, Inc. (CIK No. 1059267) is a permanently revoked Nevada corporation located in Blue Bell, Pennsylvania with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Capita Research is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-KSB for the period ended December 31, 2000, which reported a net loss of over \$2 million for the year ended 2000. As of September 15, 2008, the company's common stock (symbol "CEEG") was traded on the over-the-counter markets.

- 7. Capital Appreciation Plus LP I (CIK No. 832990) is a forfeited Delaware limited partnership located in New York, New York with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Capital Appreciation is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-Q for the period ended September 30, 1996.
- 8. Capital Dome, Inc. (CIK No. 1160422) is a delinquent Colorado corporation located in Tulsa, Oklahoma with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Capital Dome is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-QSB for the period ended October 31, 2002, which reported a net loss of \$907 for the prior three months.
- 9. Caredata.com, Inc. (CIK No. 927456) is a forfeited Delaware corporation located in Atlanta, Georgia with a class of securities registered with the Commission pursuant to Exchange Act Section 12(g). Caredata.com is delinquent in its periodic filings with the Commission, having not filed any periodic reports since it filed a Form 10-Q for the period ended September 30, 2000, which reported a net loss of over \$6 million for the prior three months. On November 15, 2000, Caredata.com filed a Chapter 7 petition in the U.S. Bankruptcy Court for the Northern District of Georgia, and the case was closed on July 12, 2006. As of September 15, 2008, the company's common stock (symbol "CDCM") was quoted on the Pink Sheets, had three market makers, and was eligible for the piggyback exception of Exchange Act Rule 15c2-11(f)(3).

B. DELINQUENT PERIODIC FILINGS

- 10. As discussed in more detail above, all of the Respondents are delinquent in their periodic filings with the Commission (*see* Chart of Delinquent Filings, attached hereto as Appendix 1), have repeatedly failed to meet their obligations to file timely periodic reports, and failed to heed delinquency letters sent to them by the Division of Corporation Finance requesting compliance with their periodic filing obligations or, through their failure to maintain a valid address on file with the Commission as required by Commission rules, did not receive such letters.
- 11. Exchange Act Section 13(a) and the rules promulgated thereunder require issuers of securities registered pursuant to Exchange Act Section 12 to file with the Commission current and accurate information in periodic reports, even if the registration is voluntary under Section 12(g). Specifically, Rule 13a-1 requires issuers to file annual reports, and Rule 13a-13 requires issuers to file quarterly reports.
- 12. As a result of the foregoing, Respondents failed to comply with Exchange Act Section 13(a) and Rules 13a-1 and 13a-13 thereunder.

III.

In view of the allegations made by the Division of Enforcement, the Commission deems it necessary and appropriate for the protection of investors that public administrative proceedings be instituted to determine:

- A. Whether the allegations contained in Section II are true and, in connection therewith, to afford the Respondents an opportunity to establish any defenses to such allegations; and,
- B. Whether it is necessary and appropriate for the protection of investors to suspend for a period not exceeding twelve months, or revoke the registration of each class of securities of the Respondents identified in Section II registered pursuant to Section 12 of the Exchange Act.

IV.

IT IS HEREBY ORDERED that a public hearing for the purpose of taking evidence on the questions set forth in Section III hereof shall be convened at a time and place to be fixed, and before an Administrative Law Judge to be designated by further order as provided by Rule 110 of the Commission's Rules of Practice [17 C.F.R. § 201.110].

IT IS HEREBY FURTHER ORDERED that Respondents shall file an Answer to the allegations contained in this Order within ten (10) days after service of this Order, as provided by Rule 220(b) of the Commission's Rules of Practice [17 C.F.R. § 201.220(b)].

If Respondents fail to file the directed Answers, or fail to appear at a hearing after being duly notified, the Respondents may be deemed in default and the proceedings may be determined against it upon consideration of this Order, the allegations of which may be deemed to be true as provided by Rules 155(a), 220(f), 221(f), and 310 of the Commission's Rules of Practice [17 C.F.R. §§ 201.155(a), 201.220(f), 201.221(f), and 201.310].

This Order shall be served forthwith upon Respondents personally or by certified or Express Mail, or by other means permitted by the Commission's Rules of Practice.

IT IS FURTHER ORDERED that the Administrative Law Judge shall issue an initial decision no later than 120 days from the date of service of this Order, pursuant to Rule 360(a)(2) of the Commission's Rules of Practice [17 C.F.R. § 201.360(a)(2)].

In the absence of an appropriate waiver, no officer or employee of the Commission engaged in the performance of investigative or prosecuting functions in this or any factually related proceeding will be permitted to participate or advise in the decision of this matter, except as witness or counsel in proceedings held pursuant to notice. Since this proceeding is not "rule making" within the meaning of Section 551 of the Administrative Procedure Act, it is not deemed subject to the provisions of Section 553 delaying the effective date of any final Commission action.

^{*}Regulation S-B and its accompanying forms, including Forms 10-QSB and 10-KSB, are in the process of being removed from the federal securities laws. See Release No. 34-56994 (Dec. 19, 2007). The removal is taking effect over a transition period that will conclude on March 15, 2009, so by that date, all reporting companies that previously filed their periodic reports on Forms 10-QSB and 10-KSB will be required to use Forms 10-Q and 10-K instead. Forms 10-QSB and 10-KSB will no longer be available, though issuers that meet the definition of a "smaller reporting company" (generally, a company that has less than \$75 million in public equity float as of the end of its most recently completed second fiscal quarter) will have the option of using new, scaled disclosure requirements that Regulation S-K now includes.
