Miss. River Commission coming to La., Aug. 26

Inspection boat will begin on Ohio River, so important to Lower Miss.

NEW ORLEANS – The Mississippi River Commission's 2005 low-water inspection trip will feature an unusual Ohio River leg before concluding in Louisiana on Aug. 26.

Members of the public are invited aboard the MV Mississippi in Morgan City to place their views and questions before the seven-member commission. The public meeting begins Friday, Aug. 26, at 9 a.m., at the Port of Morgan City dock, 800 Youngs Road.

"The Ohio River is important to the Lower Mississippi because it contributes about 60 percent of the water and the Upper Mississippi contributes the remainder," said Larry Banks, chief of the watershed division, Mississippi Valley Division, Vicksburg, Miss.

"That is why flood damage controls on the Ohio River are so important to the Lower Mississippi communities," Banks said.

On the Ohio, the commission members will get a first-hand look at the locks, dams and navigation facilities in order to prepare a report for John Paul Woodley Jr., the assistant secretary of the Army for civil works; Lt. Gen. Carl A. Strock, the chief of engineers, and the Congress.

The commission's week on the Ohio will begin Aug. 13 in Huntington, W.Va., and conclude Aug. 19 in Paducah, Ky. The commissioners will meet with local interests, projects' local partners and the other stakeholders, and also inspect and review major projects and studies.

The Mississippi River Commission includes three Corps officers because their commands include the basin's three great rivers: Brig. Gen. Robert Crear,

president-designee and division engineer, Mississippi Valley Division; Brig Gen. Bruce A. Berwick, division engineer, Great Lakes and Ohio River Division, and Col. Gregg F. Martin, division engineer, Northwestern Division (Missouri River).

"We work very closely with the Corps' Lakes and River Division in their management of flood control releases that could impact flood conditions within the Lower Mississippi Valley," Banks said.

Established in 1879, the Mississippi River Commission has seven members, nominated by the President and confirmed by the Senate. The commission advises the chief of engineers and the secretary of the Army. Staff support is provided by the Mississippi Valley Division, based in Vicksburg, Miss. The division directs the work of the six Corps districts on the Mississippi River from the Gulf of Mexico to Canada.

Public meetings on the Lower Mississippi will also include Cairo, Ill., Aug. 22; Memphis, Aug. 23; and Greenville, Miss., Aug. 24. The commission inspects the Mississippi River twice a year, in the spring during high water and in the summer during low water. It holds public meetings on each trip.
