SUBJECT: Recognition of Dependency for Purpose of Travel and Allowances

For the purposes of foreign allowances authorized by reference 1a and for travel authorized under reference 1b, the terms "legal guardianship" and "legal minor ward" include children or other dependents placed in the custody of the employee by order of a court having jurisdiction over the employee or dependent, as defined by reference 1c. Notarized statements, powers of attorney, or agreements drawn by an attorney or military judge advocate officer are not sufficient for the purpose of determining entitlements.
- 3. This definition does not apply for the purposes of establishing a member of household, nor does it apply to the Federal Employees Health Benefits Program.
