#### EAC Roundtable: Getting Ready for November

EAC hosted a roundtable discussion Tuesday, June 19, 2012. This roundtable opened up a national discussion about what to expect and how to prepare for November 2012 and beyond. #### Voting System Updates

Dominion Democracy Suite 4.9. Wyle is in the process of reviewing source code for this modification and determining test cases needed for this campaign. Wyle expects to begin work on the draft Test Plan within the next week or two. Dominion is preparing an amended application to correct version numbers for this system.

<u>Dominion Sequoia WinEDS 4.0</u>. EAC is in discussion with Dominion about the next steps in this test campaign.

Election Systems & Software (ES&S) Unity 3.4.0.0. The EAC approved the Test Plan for this campaign on July 17, 2012. EAC is working with Wyle and ESS to clarify information about the root cause analysis for the "Decision Late" discrepancy. ES&S submitted a revised application on August 3, 2012, to remove modeming functionality from this test campaign.

## **TECHNICAL UPDATES**

Election Systems & Software (ES&S) EVS 5.0.0.0. Upon completion of Test Case Sequencing for ERM and Express vote, and acceptance of the Test Plan, ES&S halted testing on EVS 5.0.0.0. EAC approved the Test Plan on July 20, 2012.

#### EAC & Military Heroes Initiative Update

On Tuesday, July 24th, ITIF hosted an event to provide an <u>overview of their research</u> on making voting accessible for disabled veterans. The presentation was held at the Russell Senate Office Building. This event focused on a discussion of the barriers that exist for disabled service members and ways to improve voting access for them.

**Background:** In FY 2009 and FY 2010, Congress provided funds to the EAC to develop a research program to continue to support accessible voting technology. In September 2010, EAC <u>awarded</u> a \$500,000 grant to the Information Technology and Innovation Foundation (ITIF) to research the needs of recently injured military personnel with regard to the federal election process. This initiative was developed by EAC and the Department of Defense Federal Voting Assistance Program (FVAP).

#### State Certification Meeting Wrap Up

On June 14th and 15th, Ball State University's Bowen Center for Public Affairs hosted the second annual State Certification Testing of Voting Systems National Conference in Indianapolis, IN. The first meeting on state certification was held in September 2011 at the Center for Election Systems at Kennesaw State University, Kennesaw, Georgia. Participants found the event so useful, they began building a network of state officials and academics with whom to share information and advice. During that meeting, the participants decided the event should be repeated and expanded.

The primary goal of the conference was to provide a venue for practitioners and academics to share best practices; explore more efficient and effective methods of testing voting systems; and to identify common challenges and potential mitigations to those challenges. A secondary goal was to improve the quantity and quality of information that flows between the state, county, township and federal testing entities. View the topics and presentations

#### **Quality Monitoring Program**

EAC's <u>Quality Monitoring Program</u> is designed to ensure that voting systems certified by EAC are the same systems sold by manufacturers. The quality monitoring process is a mandatory part of the program and includes elements such as fielded voting system review, anomaly reporting, and manufacturing site visits. The <u>system advisory alerts</u> include recommended procedures, possible root causes and contact information for those jurisdictions with additional questions.

Election Officials can report voting system anomalies to the EAC utilizing the <u>Voting System Anomaly Reporting Web</u> Form.

#### **Voting System Reports Collection**

As part of EAC's clearinghouse responsibilities under Section 202 of the Help America Vote Act, the commission adopted a policy authorizing staff to post and distribute voting system reports and studies that have been conducted or commissioned by a state or local government. EAC encourages state and local governments to submit their voting system reports and studies so they may be shared with the broader election community and the public.
