The purpose of this modification is to obligate American Recovery and Reinvestment Act (Recovery Act) (ARRA) of 2009 funds for Revision No. 01 to the Work authorization for the project entitled, “Characterization, Verification and Technical Support to ORO Environmental Management in support of the Non-Defense ARRA Work at Oak Ridge National Laboratory,” in the amount of \$379,000.

B. Accordingly, clause B.4 Obligation of Funds, paragraph (a) is revised as follows:

“Pursuant to the clause Section I, FAR 52.232-22 entitled ‘Limitation of Funds,’ total funds in the amount of \$713,620,727.83 are obligated herewith and made available for payment of allowable costs and maximum fee to be incurred from the effective date of this contract through the period estimated to end December 31, 2010.”
