The purpose of this modification is to obligate American Recovery and Reinvestment Act (Recovery Act) of 2009 funds for the Work authorization for the project entitled “Characterization, Verification, and Technical Support to ORO Environmental Management in support of the Non-Defense ARRA Work at Oak Ridge National Laboratory” in the amount of \$655,044.00.
