This revision to Project Code 2002100, Characterization, Verification and Technical Support to ORO Environmental Management in support of the Defense ARRA Work at Y-12 National Security Complex moves \$200,000 from the West End Mercury Area (WEMA) Storm Sewer Remediation Project to the Alpha 5 Project.
