SUBJECT: SUMMARY OF OCTOBER 19-20, 2010, NRC PUBLIC
WORKSHOP ON DEVELOPMENT OF A REGULATORY

On October 19-20, 2010, the U.S. Nuclear Regulatory Commission (NRC) hosted a public workshop to discuss issues associated with the development of a regulatory framework for spent nuclear fuel reprocessing facilities. The purpose of the workshop was to solicit the views and perspectives of stakeholders regarding the technical and regulatory issues that the NRC staff is addressing in the development of a reprocessing regulatory framework.

To elicit a diverse set of views from stakeholders, the NRC invited a diverse panel of stakeholders; which included NRC staff, citizen and environmental groups, nuclear industry representatives, and other Federal agencies. The workshop discussions followed a roundtable discussion format, moderated by a professional facilitator, to promote dialogue and discussion among panelists. All discussions began with a brief NRC staff presentation of the issues, followed by a roundtable discussion among panelists; and concluded by an opportunity for questions and comments from members of the public.
