Overview: FederalRegister.gov



- Federal Register 2.0 or “FR2”
- Launched July 26, 2010
 - Built on top of GovPulse.us platform
 - Sunlight Foundation “Apps for America” winner
 - FR2 Team: NARA-OFR/GPO Partnership
 - Plus: CriticalJuncture.org (SF, CA) & FedCMS.com (DC area)
- API Released August 2011

Open Source Code



- FederalRegister.gov is fully open source
- GitHub: github.com/criticaljuncture
 - Source code for the main site.
 - Chef cookbooks for maintaining the servers.
 - WordPress themes and configuration.
- We welcome contributions & feedback

API Details



- Pre-processed, cleaned up data provided:
 - Combination of data from GPO MODS (metadata) files and GPO bulk data files after cleanup procedures.
- JSON for lighter-weight, web-friendly data transfer format.
- No API keys needed
 - Just HTTP client or browser.
- The API is fully RESTful
 - URLs provided to navigate to full details or to next page of results (HATEOAS).
- Simple JSONP interface also possible
 - Simply add a `callback=foo` CGI parameter to the end of any URL to have results ready for cross-domain JavaScript consumption.

What Data is in FR API?



- All of FederalRegister.gov – each document & metadata
- Create own FR, or select portions for your app or website
 - Information about all agencies in FederalRegister.gov database.
 - Metadata & details about a particular FR article, or many.
 - Full search, matching our advanced search.
 - Details of documents on Public Inspection on a particular date, or the current date.
 - Public Inspection search.
 - Single or multiple Public Inspection documents.

Consumers of Federal Register API



- **Polar Bear App**
 - Finds “polar bear” in Federal Register docs; creates browseable list, RSS feed, detailed view of each item; dynamically generates charts and maps.
 - Environmentalists, animal protectionists, trophy hunters track U.S. actions on polar bears, including drafts of new regulations, issuance of permits.
- **Financial Services Firms**
- **Sunlight Labs Scout**
 - Legal and Regulatory information/alert system covering Congress, regulations across executive branch, and legislation in all 50 states.

What's Next: Regulations.gov Integration



- Data Harmonization Working Group
 - OMB/OIRA, Regulations.gov PMO, GSA/RISC, OFR, GPO
- As Is State: OFR crawls Regulations.gov/FDMS for docs open for comment, supporting material, submitted comments.
 - Big green easy button to “Submit a Formal Comment”
 - Comment Countdown Clock
 - Direct Access to Comment Dockets w/out restarting search
- Future State: Consume Regs.gov API into FR2 API for seamless access.
 - Allow users to submit comments directly from FR2 (no wrong portal)
 - Add notifications: when comment accepted; when others comment; when next related doc is published or open for comment (same RIN); when comments are closing
 - Widget sharing: Interest Groups; Agencies, USA Search
