**MEETING SUMMARY**

**PURPOSE**

To discuss issues related to the Advisory Committee on the Medical Uses of Isotopes (ACMUI) reporting structure.

**OUTCOME**

The ACMUI made a recommendation to continue to report to U.S. Nuclear Regulatory Commission (NRC) staff rather than report directly to the Commission. However, the ACMUI requested additional resources for support staff. NRC staff gained a better understanding of the views and opinions of the ACMUI as well as other stakeholders' on this topic. The staff will consider these views in its continuing effort to work closely with the ACMUI on medical policy issues and in developing a recommendation to the Commission on the Committee reporting structure.
