

**TELECONFERENCE MEETING OF THE
ADVISORY COMMITTEE ON THE
MEDICAL USES OF ISOTOPES**

December 15, 2011

MEETING SUMMARY

PURPOSE

To discuss the 2008 Advisory Committee on the Medical Uses of Isotopes (ACMUI) recommendations for Abnormal Occurrence (AO) medical event reporting criteria.

OUTCOME

The ACMUI endorsed their 2008 position, which is summarized by the following: AOs for medical licensees should be events which result in death or threaten life; AOs should not capture errors that are typically a function of treatment; AOs should be of significant adverse effect; AO criteria should be qualitative and not quantitative. The U.S. Nuclear Regulatory Commission (NRC) staff gained a better understanding of the views and opinions of the ACMUI, as well as other stakeholders' views and opinions. The staff will consider these views in revising the AO criteria for medical licensees. The current AO criteria can be found in the *Federal Register* Volume 71 Number 197 Page 60200 dated October 12, 2006.

RECOMMENDATIONS AND ACTIONS

The ACMUI confirmed their recommendation from 2008 with one amendment. The criteria below was revised to indicate more than one physician could be consulted. The final recommendation read, as follows:

An Abnormal Occurrence is a medical event that results in a) death; or b) a significant impact on patient health that would result in permanent functional damage or a significant adverse health effect that would not have been expected from the normal treatment regimen, as determined by the NRC or Agreement State designated consultant physician(s).

The recommendation above was approved by the ACMUI with 11 favorable votes and one opposing vote.
