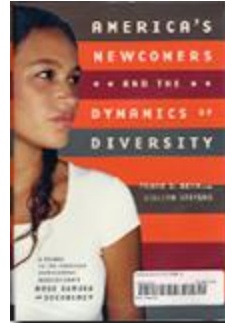

With the exception of unauthorized Mexican and Central American immigrants, studies show that most other immigrant groups have attained sufficient earnings and jobs mobility to move into the economic mainstream.
