# "Closing the efficacy-effectiveness gap"

Editor's note: The June issue commenced a series of articles focused on "Recovery" and on "recovery oriented services." Implementing recovery oriented services is a major goal of the President's New Freedom Commission on Mental Health, as well as a goal of the VA's Comprehensive Mental Health Strategic Plan. The South Central MIRECC has made promoting recovery oriented services a major educational theme. Below is a description of a MIRECC-sponsored training in psychosocial rehabilitation that was conducted in May.

# Training in Recovery and Psychosocial Rehabilitation

The South Central MIRECC sponsored training in the Recovery Model and Psychosocial Rehabilitation, May 17-19, 2006 in Little Rock, AR. This training was an extension of an intensive training in psychosocial rehabilitation that was conducted in 2004. Seven of the 16 clinicians trained as trainers in that program planned and led the May training. Lisa Martone, APN from CAVHS coordinated the program. Others involved in the planning and training effort included Delores Hendrix-Giles, SW (Houston), Kathy Dohoney, PsyD (Dallas), Wayne Gregory, PhD (Waco, TX), Mike Nichols, Vocational Counselor (Little Rock), Sylvia Ranson, RN (Little Rock), and Craig Rookey, PhD (Little Rock). Kathy Henderson, MD, Manager, VISN 16 Mental Health Product Line, and Michael Kauth, PhD, Co-Director, South Central MIRECC, welcomed participants to the training and discussed the importance of implementing recovery oriented systems of care for veterans who receive mental health services. The keynote speaker for the event was Christine Woods, Consultant for the Psychosocial Rehabilitation and Recovery Programs, VACO.

Twenty-four clinicians from VISN 16, VISN 17, and VISN 9 participated in the training. Facilities in VISN 16 that had not participated in the 2004 training sent clinicians. Every facility in VISN 16 now has staff who are trained in the recovery model and in psychosocial rehabilitation skills. The facilities themselves supported travel for their clinicians.

Content of the training included "Why, How, and When VA Becomes a Recovery-Oriented Mental Health System" (keynote address); Recovery and Psychosocial Rehabilitation (PSR) Models, principles, values, goals, and services; stigma and myths about mental illness; the role of Vocational Rehabilitation in PSR; motivational interviewing; person centered planning and the stages of change; peer support and consumer councils. In these presentations, the Medical Model and the Recovery Model—the message of hope, empowerment, and focusing on strengths rather than deficits. It is important for each veteran to be responsible for developing his/her own "recovery plan." Each recovery plan is individual and depends upon the goals, interests, strengths, and resources of the individual veteran. The role of the provider in this model is to assist the veteran to acquire the skills/knowledge/opportunities necessary to attain those

personal goals. A variety of choices for treatment options is essential. Most presenters noted the need for change in the VA in order to incorporate evidence-based practices consistent with the Recovery Model and PSR. The role of stigma in perpetuating obstacles that persons with mental illness—as well as clinical providers—must overcome in order to reach their goals was also addressed.

PSR skills were modeled by trainers. Trainees gave return demonstrations. Participants were also required to pass a written examination at the conclusion of the training. As a follow up to this training, trainees will meet monthly on conference calls to continue learning about recovery and psychosocial rehabilitation. They are expected to work with their clinical programs and the Mental Health Leadership at their facilities to develop and implement a recovery model of care and psychosocial rehabilitation services in the next year.

The South Central MIRECC announced a call for **Clinical Education grant proposals by August 21, 2006**. Attached are the application and a list of previously funded, active projects. The purposes of the grants are to support the development and evaluation of innovative clinical education tools or creative methods for delivering effective mental health care by frontline clinicians. Recipients may be awarded up to \$7,000. To date, 65 grants have been awarded through this program, and a number of fine clinical education tools have been developed. If you are thinking about submitting a proposal, the FIRST THING you should do is to *talk to someone in MIRECC Education about your idea*. MIRECC personnel will help you develop your idea into a proposal that has a good likelihood of being funded. Projects related to promoting recovery-oriented education and services are a funding priority. A recovery orientation takes a holistic, multi-dimensional view of the veteran that includes physical and mental health, spirituality, occupational functioning, social functioning, etc., within a family and within the community. A recovery orientation strives to improve general functioning and promote hope. The application deadline is October 2, 2006.
