If embarrassment arising from the dispute between various factions of the Hughes organization was the reason for not using or returning the funds in 1970 and 1972, why were other contributions sought from Hughes in April of 1972?

M Rebozo subsequently had a conversation with Kalmbach on this matter January 8, 1974 at San Clemente. On that occasion *M* Rebozo told *M* Kalmbach that the money he (Rebozo) had given to Donald and Edward Nixon and Rose Mary Woods was not from the Hughes money, but from other monies which he had for such purposes. Between May 1, 1973 and January 8, 1974, when *M* Rebozo next met with *M* Kalmbach, did you and *M* Rebozo have a discussion as to what *M* Rebozo should tell *M* Kalmbach?

In October 1973 General Alexander Haig stated to Kenneth Gemmill, according to Mr. Gemmill's testimony before the Senate Select Committee, that analysis of the notes returned to Hughes from Rebozo proved that it was not the original money. When first interrogated about the Hughes money by Internal Revenue Service agents May 10, 1973, Mr. Rebozo stated that he had not told anyone about the money and that no one knew about the money except the agents and himself. In the early fall of 1973, ^{his} attorney Kenneth Gemmill notified the Internal Revenue Service agents that Rebozo then recalled having told Rose Mary Woods shortly after each of the two deliveries. In March 1974 in his testimony before the Senate Select Committee, Rebozo stated that sometime after the 1972 election he told you about the Hughes money. Between May 1973 and when Rebozo was first interviewed by the agents and October 1973 when Gemmill advised the IRS that Rebozo had reported the deliveries to Rose Mary Woods, did you have any discussion with Charles Rebozo relating to whether he had contemporaneously advised anyone such as Rose Woods of the fact ~~that~~ of the deliveries?

In his testimony before the Senate Select Committee in March of 1974, Rebozo stated that in addition to receiving \$100,000 in cash in the form of hundred dollar bills from Richard Danner on behalf of Howard Hughes in 1970, he also received \$50,000 in cash in hundred dollar bills from A. D. Davis on or about April 5, 1972. Was the receipt of the Davis money reported to you by Rebozo or anyone else at the time?
