SUBJECT: Distribution of the McIntire-Stennis Cooperative Forestry Act Funds
for Fiscal Year (FY) 2009

Attached is a copy of the CSREES-OD-1088-D, Distribution of McIntire-Stennis Funds for FY 2009. These funds are allocated under section 6 of the McIntire-Stennis Act (16 U.S.C. 582A). The distribution identifies funds for the Small Business Innovation Research Program, reflecting the requirement that not less than 2.50 percent of the funds be set aside for that purpose in FY 2009, and a set aside for biotechnology risk assessment.

Section 7412 of the Food, Conservation, and Energy Act of 2008 (P.L. 110-246) (i.e., the 2008 Farm Bill) amended section 2 of the McIntire-Stennis Cooperative Forestry Act of October 10, 1962 (16 U.S.C. 582a et seq.). This provision expanded program eligibility to all 1890 Land-Grant Institutions. The FY 2009 allocation reflects this change.

CSREES transitioned to Grants.gov for the submission of all administrative requirements via the SF-424, Mandatory Application Forms in FY 2007. CSREES will be soliciting for the applications via the FY 2009 McIntire-Stennis Cooperative Forestry Research Program Formula Grant Opportunities (FGO) - Final which will provide instructions for the completion and submission of these forms. CSREES will notify eligible institutions when the instructions and forms are available on the Grants.gov site. Therefore, there are no reporting requirements at this time. Please note that this process will not change any current reporting processes such as the Current Research Information System. The FGO for this program will be released within seven (7) days of this memorandum.
