## WIRELESS TELECOMMUNICATIONS BUREAU ANNOUNCES REVISED ELECTION DATE (JANUARY 31, 2001) AND AMENDED ELIGIBILITY LIST FOR 218-219 MHZ SERVICE

On September 7, 1999, the Federal Communications Commission ("Commission") adopted the 218-219 MHz Order, which, among other things, included a restructuring plan for existing licensees that: (i) were current on installment payments as of March 16, 1998; (ii) were less than ninety days delinquent on the last installment payment due before March 16, 1998; or (iii) had pending properly filed grace period requests under the former installment payment rules ("Eligible Licensees"). The Commission permitted Eligible Licensees to elect among three options: (i) Reamortization and Resumption of Payments; (ii) Amnesty; or (iii) Prepayment. The Commission also stated that Eligible Licensees that fail to submit an election with respect to any license by Election Day will be assumed to have elected Amnesty.

On December 28, 1999, a Preliminary Implementation Procedures *Public Notice* was issued which announced that Eligible Licensees had to make their elections by 7 p.m., February 29, 2000.<sup>2</sup> In order to allow sufficient time to address the issues raised in the various petitions for reconsideration of the *218-219 MHz Order*, the Commission decided to change the Election Date to the last business day of the first full month after an Order on the petitions for reconsideration was released.<sup>3</sup> On December 13, 2000, the Commission released an Order addressing the aforementioned petitions for reconsideration.<sup>4</sup> Accordingly, Eligible Licensees must make their elections by 7 p.m., Wednesday, January 31, 2001.<sup>5</sup> **NO ELECTIONS**
