

Installation
ALCOHOLIC BEVERAGES

History. This is the first change issued to III Corps and Fort Hood Regulation 210-65 dated 1 May 1995.

Summary. This change clarifies authority to authorize the distribution and consumption of alcohol during unit sponsored social events Fort Hood.

Applicability. Policy outlined in this change applies to all active duty military assigned or attached to Fort Hood, and military members of National Guard or Reserve Units training at Fort Hood.

Changes. Changes are not official unless authenticated by the Directorate of Information management.

1. Change Fort Hood Regulation 210-65, 1 May 1995, as follows:

Page 2, paragraph 1b, lines 1-2; replace with:

AR 215-1 (Nonappropriated Fund Instrumentalities and Morale, Welfare, and Recreation Activities)

Page 3, paragraph 3b, lines 2-4; replace with:

Soldiers, except as in block 7a, are prohibited from

- Having a blood alcohol level of .04 percent or above during duty hours except when a soldier did not know, or have a reasonable expectation prior to becoming impaired, that they had duties to perform

Page 7-8. Paragraph 7a; replace with:

Alcoholic beverages may be served and consumed by soldiers over the age of 21:

- During normal duty hours when they:
 - Have been released from duty for the remainder of the duty day (i.e., off-duty).
 - Are on leave.
 - Are on official pass.
 - Are on a training holiday.
 - Are otherwise absent from duty with proper authority.
 - Are outside barracks in areas designated by the unit commander.
- In and around family quarters, as long as related activities do not disturb surrounding residents.
- At designated recreation areas (lakes and parks), recreation centers, community theaters, and music centers during dinner-theater productions when not on duty and after normal duty hours provided it is a malt or wine beverage.
- During Thanksgiving, Christmas, and other appropriate holiday season activities in offices or designated work area during sponsored holiday events provided that:
 - The responsible battalion commander or equivalent civilian supervisor obtains written authority from the first general officer in the unit or office chain of command
 - Alcoholic beverages are not served before 1100.
- By soldiers during normal duty hours, for unit sponsored social events, organizational days or promotion parties provided that:
 - The responsible battalion commander gets written authority from the first general officer in the unit chain of command.

- Alcoholic beverages are not served prior to 1100
- Alcoholic beverages are not served during Officer and Noncommissioned Officer Professional Developments and other training events

Page 9, paragraph 7b, line 6 and 7; replace with:

Soldiers in uniform may not purchase individual servings of alcohol or servings of alcohol by the drink prior to 1630 on duty days unless granted authority pursuant to paragraph 7a of this regulation.

Page 9, paragraph 7b, lines 13-15; remove.

Page A-2, Key 2; replace with:

Sell alcoholic beverages by the drink on the installation only after 1630 on weekdays and during normal operating hours on weekends and holidays unless authority is granted pursuant to this regulation.

Page A-2, Key 3; delete.

2. File this change directly in front of the basic Fort Hood Regulation 210-65 according to AR 310-13.
