Corrections Partnerships Concept Paper

Dear Colleague:

The National Institute of Justice and the Corrections Program Office of the Office of Justice Programs (OJP) are pleased to announce a unique opportunity to foster researcher-practitioner partnerships to undertake research in the areas of corrections; community corrections; probation; parole; or sentencing impacts of the 1994 Crime Act. We are requesting that researcher-practitioner partnerships be developed to submit a concept paper proposing a research or evaluation activity in one of the <u>suggested areas</u> attached.

All those submitting concept papers will be invited to a working session sponsored by OJP to help translate the concept papers into full proposals; the workshop will be held in early May in Washington DC. Topics to be discussed at this workshop will include issues such as "when is a partnership really a partnership;" barriers to effective partnerships; methodological issues raised through concept paper review; writing effective proposals; NIJ proposal review process; and CPO technical assistance.

Those attending will be encouraged to submit full proposals. For the *Residential Substance Abuse Treatment for State Prisoners (RSAT) partnership solicitation*, the relevant process evaluation cycle deadline will be 9/15/98, where up to ten awards of a maximum of \$60,000 each are expected to be given. For the *partnership section of the Research and Evaluation on Sentencing Reforms and Their Effects on Corrections Solicitation*, the relevant cycle deadline will be June 29, 1998, where up to ten awards of a maximum of \$150,000 are expected to be given.

Concept papers should be five to ten double-spaced pages in length, and are due to NIJ no later than close of business on **Tuesday**, **April 7**th. The concept papers should outline the following:

- 1. Statement of the problem and importance to the field;
- 2. General goals and objectives of the research;
- 3. General study design and methodological approach expected;
- 4. Expected management plan;
- 5. Description of the working partnership, and supporting letters.

Detailed budgets are not required, but the scope of the proposed work should be in line with the amounts described above, i.e., up to \$60,000 for the RSAT process evaluation solicitation and up to \$150,000 for the Violent Offender/Truth in Sentencing (VOI/TIS) solicitation. - Impact on prison release and release procedures.
