REMARKS: IMC 2602 (Decommissioning Oversight and Inspection Program for Fuel Cycle and Materials Licensees) has been revised to reflect new organizational changes and new procedures.

IP 35017 (Quality Assurance Implementation Inspection) has been revised to change Program Applicability to include IMC 2501, "Construction Inspection Program: Early Site Permit (ESP)" and IMC 2508, "Construction Inspection Program: Design Certification." The inspection procedure was also revised to align with NUREG-0800, "Standard Review Plan for the Review of Safety Analysis Reports for Nuclear Power Plants."

IP 42454 (Part 52, Emergency Procedures) is issued to support inspections of operational programs described in IMC 2504, "Construction Inspection Program - Non-ITAAC Inspections."

IP 65001.07 (Inspection of ITAAC-Related Installation of Valves) is to support Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC)-related inspections under 10 CFR Part 52 guidance.

IP 65001.12 (Inspection of ITAAC-Related Installation of Heating, Ventilating, and Air Conditioning Systems) is issued to support ITAAC-related inspections under 10 CFR Part 52 guidance.

IP 65001.14 (Inspection of ITAAC-Related Installation of Complex Systems with Multiple Components) is issued to support ITAAC-related inspections under 10 CFR Part 52 guidance.

IP 83746 (Part 52, Offsite Dose Calculation Manual (ODCM)) is issued to support inspections of operational programs described in non-ITACC inspections.

TI 0610/001 (Guidance for Certain Fuel Cycle Inspection Reports to Pilot Use of NRC Form 591) has been deleted. Elements of TI 0610/001 were incorporated into IMC 0616"; therefore this TI is no longer needed.

IMC 0616 (Fuel Cycle Safety and Safeguards Inspection Reports) is issued for use by Fuel Cycle Safety and Safeguards (FCSS) and Region II inspectors. These Offices will no longer use IMC 0610, "Nuclear Material Safety and Safeguards Inspection Reports."
