REMARKS: IMC 1202 (Senior Resident and Resident Inspector Site Turnover) has been revised to update and clarify the turnover process for Senior Resident Inspectors (SRIs) and Resident Inspectors (RIs) and to respond to Reactor Oversight Process (ROP) feedback forms.

. TI 2515/173, Rev 1 (Review of the Implementation of the Industry Ground Water Protection Voluntary Initiative) has been revised to change reporting requirements and documentation.

IP 52001, "Digital Retrofits Receiving Prior Approval" has been deleted.

IP 52002, "Digital Retrofits Not Receiving Prior Approval" has been deleted.

IP 52003 (Digital Instrumentation and Control Modification Inspection) is issued as a new inspection procedure to combine and replace IP 52001, "Digital Retrofits Receiving Prior Approval" and IP 52002, "Digital Retrofits Not Receiving Prior Approval."

IP 71003 (Post-Approval Site Inspection for License Renewal) has been revised to correct dates in Attachment 1, "Original Operating License Expiration Dates" for the following plants: Indian Point Nuclear Generating Unit 3, Seabrook Station, Virgil C. Summer Nuclear Station, McGuire Nuclear Station Unit 2, Duane Arnold Energy Center, Diablo Canyon Power Plant Units 1 and 2, Palo Verde Nuclear Station Units 1, 2 and 3.

IP 71111.17 (Evaluations of Changes, Tests, or Experiments and Permanent Plant Modifications) has been revised to include consideration of Generic Safety Issue (GSI) 191, "Assessment Of Debris Accumulation on PWR Sump Performance" related to potential sump blockage.

IP 71111.18 (Plant Modifications) has been revised to include consideration of Generic Safety Issue (GSI) 191, "Assessment Of Debris Accumulation on PWR Sump Performance" related to potential sump blockage and to incorporate editorial revisions.

IP 71114.04 (Emergency Action Level and Emergency Plan Changes) has been revised to incorporate a review of security-related Emergency Action Level (EAL) and Emergency Plan changes.
