IMC 1246 Appendix B, Section XVII (Fuel Cycle Project Manager Qualification Journal) is issued to add a new qualification journal for Fuel Cycle Project Managers

IMC 2800 (Materials Inspection Program) has been revised to clarify the process for coordination with the Agreement States and other regions, remove Enclosure 7, update definitions, and make editorial corrections.

The procedure is issued as a part of the 10 CFR Part 50 construction inspection program to support the resumption of construction activities at Watts Bar Unit 2. The inspection of construction activities at Watts Bar Unit 2, following restart of construction in 2007, is governed by Inspection Manual Chapter 2517, "Watts Bar Unit 2 Construction Inspection Program."
