Proctor Lake Hunting Policy (2012-2013)

- 1. All State and Federal hunting laws apply.
- 2. All Title 36 CFR 327 Rules and Regulations apply.
- 3. All hunters must have a valid driver's License or State issued identification card, a valid Texas hunting License, and a valid Proctor Lake Hunting Permit.
- 4. All hunters must have successfully completed a certified Hunter's Safety Course if required by state law.
- 5. Hunting allowed by permit only.
- 6. Parking allowed in designated areas by permit only. Parking permit issued with hunting permit.
- 7. No motorized vehicles of any kind are allowed in the hunting areas.
- 8. Rifles, Muzzle-loading rifles, pistols, and revolvers are not allowed.
- 9. Hunting or shooting is not allowed within 200 yards (600 feet) of homes, developed parks, roads, buildings, Government boundary lines, or other designated areas.
- 10. All trash must be taken out by the hunter. Pack it in, Pack it out!
- 11. Temporary blinds may be erected by the permitted hunter and must be removed at the end of each day. The Government is not responsible for any blinds left on Government property.
- 12. The cutting of any vegetation to construct a blind is prohibited.
- 13. Only one blind per hunter is allowed.
- 14. Hunters are allowed two guests to accompany them while hunting. State issued Driver's license or identification card, valid Texas hunting license, and hunter's safety certificate (as listed above) if guests are hunting. Guest must be present with permitted hunter at all times.
- 15. Hunters are allowed to hunt in their assigned areas and at assigned times only.
- 16. All harvested animals and parts thereof with exception to the entrails must be removed from Government land.
- 17. The use of dogs for chasing and capture is prohibited.
- 18. Trapping of any kind is not allowed.
- 19. The Sharing of hunting permits and parking permits is not allowed.
- 20. Permits issued are for the Sabanna River Wildlife Management Area and/or the Upper Leon River Wildlife Management Area only. Hunting is not allowed in the Lower Leon River Area (below the dam).
- 21. All hunters and anyone accompanying the hunter must wear 400 square inches of hunter orange (144 inches on both chest and back) and hunter orange headwear.
- 22. Deer, Turkey, and Upland Game Birds are not allowed to be harvested.
- 23. It is recommended to read the Fort Worth District Hunting Guide for any additional rules and regulations.
- 24. Permitted hunting of feral hogs is allowed from two hours previous to sunrise until two hours after sunset. All other game must be hunted within state mandated shooting hours.
- 25. Failure to comply with all policies, rules and regulations will result in the forfeiture of hunting permit.
