

he 2009 Safety Belt Usage by CMV Drivers Survey results released by the U.S. Department of Transportation's Federal Motor Carrier Safety Administration (FMCSA) show 74 percent of commercial truck and bus drivers are now using their safety belts. Only 65 percent of drivers were using safety belts in 2007.

"Safety belts save lives," said U.S. Transportation Secretary Ray LaHood. "We applaud those who are buckling up, but we won't rest until every commercial driver is using a safety belt."

"Driving a 40-ton truck or a bus full of people is a big responsibility," said FMCSA Administrator Anne S. Ferro. (Safety Belt...continued on page 2)

INTERNATIONAL REGISTRATION PLAN, INC.

ommercial motor vehicle operators roll seamlessly across the continent to bring us the goods we need, eased in part by the International Registration Plan (IRP). IRP is a registration reciprocity agreement among the 48 contiguous United States, the District of Columbia and provinces of Canada, providing for payment of fees on the basis of total distance operated in all jurisdictions.

Before IRP, motor carriers operating in more than one jurisdiction needed to obtain multiple plates and cab cards. Now a carrier needs only a single license plate and cab card to travel among jurisdictions. IRP allows for freedom of movement for over two million vehicles, and generates more than two billion dollars in revenue for IRP member jurisdictions to support highway infrastructure and safety programs.

Timely and accurate exchange of information among its member jurisdictions is the foundation upon which IRP is built; and it all starts

with the records a commercial motor carrier driver keeps. Motor carriers that maintain proper records are generally considered to be safer than their counterparts that do not accurately document operations.

Additionally, better record keeping means that jurisdictions receive their fair share of revenue based on actual distance traveled on their highways. This revenue is in turn used to maintain and improve our highway infrastructure and safety.

To alleviate some of the burden member jurisdictions face, IRP, Inc. developed a video training program that provides a brief history on IRP and demonstrates how accurate record keeping is not only a good business practice, but is required for apportioned registration.

"Drivers owe it to themselves and others to wear a safety belt every time they get behind the wheel."


A total of 20,818 commercial drivers operating medium- to heavy-duty trucks and buses were observed at 827 roadside sites nationwide for the survey.


Key findings include:

- Safety belt use for both commercial drivers and their occupants was higher at 78 percent in states with primary safety belt laws, versus 67 percent in states with secondary safety belt laws.
- Commercial drivers for regional or national fleets showed higher safety belt use at 78 percent, versus 64 percent for independent owner-operators.
- Safety belt use rates for commercial drivers and their occupants were highest at 79 percent in the West, compared with 75 percent in the South, 68 percent in the Midwest, and 64 percent in the Northeast.

On November 13, 2009, Anne S. According to national statistics, overall men. In 2008, the National Highway Traffic Safety Administration reported 80 percent of women used their safety belts in passenger cars compared to 81 percent of men. However, the 2009 Safety Belt Usage by CMV Driver Survey conducted by FMCSA found that 86 percent of women drivers in the commerical vehicles used their safety belts compared to 74 percent of men – a 12 percent margin among commercial vehicles compared to 1 percent in passenger cars. We can only project that as the number of women in trucking continues to grow, we will see an increase in safety belt use in the commercial vehicle industry.


