SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The Pacific Exchange filed a proposed rule change (SR-PCX-99-04) relating to increasing the maximum order size eligible for automatic execution on Auto-Ex to fifty contracts. Publication of the proposal is expected in the Federal Register during the week of July 19. (Rel. 34-41611)

The Chicago Board Options Exchange filed a proposed rule change (SR-CBOE-99-29) to allow RAES orders to trade against orders in the exchange's limit order book. Publication of the proposal is expected in the Federal Register during the week of July 19. (Rel. 34-41621)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-99-10) to amend NYSE Rule 123A.40 to allow specialists to make a bid or offer that betters the market at a price that would elect stop orders and eliminate the requirement to obtain Floor Official approval, unless the price of the specialist's electing transaction is more than 4/16 point away from the previous sale. Publication of the notice is expected in the Federal Register during the week of July 19. (Rel. 34-41623)
